

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on March 19, 1975, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this 25th day of March, 1975, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, David Fasken, seeks approval of an unorthodox location for his Feil Federal Well No. 1, to be drilled 660 feet from the North line and 660 feet from the West line of Section 28, Township 20 South, Range 25 East, NMPM, to test the Morrow formation, Cemetery-Morrow Gas Pool, Eddy County, New Mexico.

(3) That the N/2 of said Section 28 is to be dedicated to the well.

(4) That a well at said unorthodox location will better enable applicant to produce the gas underlying the proration unit.

(5) That no offset operator objected to the proposed unorthodox location. Case No. 5442 Order No. R-4990

That approval of the subject application will afford (6) the applicant the opportunity to produce its just and equitable share of the gas in the subject pool, will prevent the economic loss caused by the drilling of unnecessary wells, avoid the augmentation of risk arising from the drilling of an excessive number of wells, and will otherwise prevent waste and protect correlative rights.

IT IS THEREFORE ORDERED:

That an unorthodox gas well location for the Morrow (1) formation is hereby approved for applicant's Feil Federal Well No. 1, to be drilled at a point 660 feet from the North line and 660 feet from the West line of Section 28, Township 20 South, Range 25 East, NMPM, Cemetery-Morrow Gas Pool, Eddy County, New Mexico.

That the N/2 of said Section 28 shall be dedicated to (2) the above-described well.

That jurisdiction of this cause is retained for the (3) entry of such further orders as the Commission may deem necessary.
