### Arena Resources Inc. West Satellite Battery Pit Closure North Benson Queen Unit, Well No. 029

While preparing the surface to reconfigure the West Satellite Battery, Arena Resources uncovered the original drilling pit for the now P&A'd production well number 029. Initial laboratory analysis of the top 2 to 3 feet of pit material showed hydrocarbon levels below 100 ppm TPH and no evidence of chloride contamination (see attached analyses).

Per NMOCD guidance, Arena Resources will excavate the remaining original drill cuttings and pit materials and stockpile on location for further analysis. Once this is complete, soil samples will be taken from the open pit to determine if any impacts from hydrocarbons or chlorides are present.

Once the NMOCD is satisfied that the pit has been remediated per NMOCD guidelines, the pit will be lined per NMOCD rule 50, the excavated materials will be returned to the lined pit, the pit will be capped with another liner per NMOCD rule 50, and the battery will be rebuilt on top of the location. This will effectively provide an extra measure of containment for the new battery with two liners beneath it.



- 1. The old drilling pit will be excavated to clean soils as indicated by bottom sample, or three feet. The excavated material can be disposed of in one of the new drilling pits. This will include deep burial inside an approved liner per NMOCD rule 50. This will also require NMOCD approval.
- 2. The excavation will be inspected by BLM prior to closure.
- 3. The excavation will be backfilled with clean caliche, this can be obtained from abandoned locations or from nearby caliche pits.
