
Gentlemen:



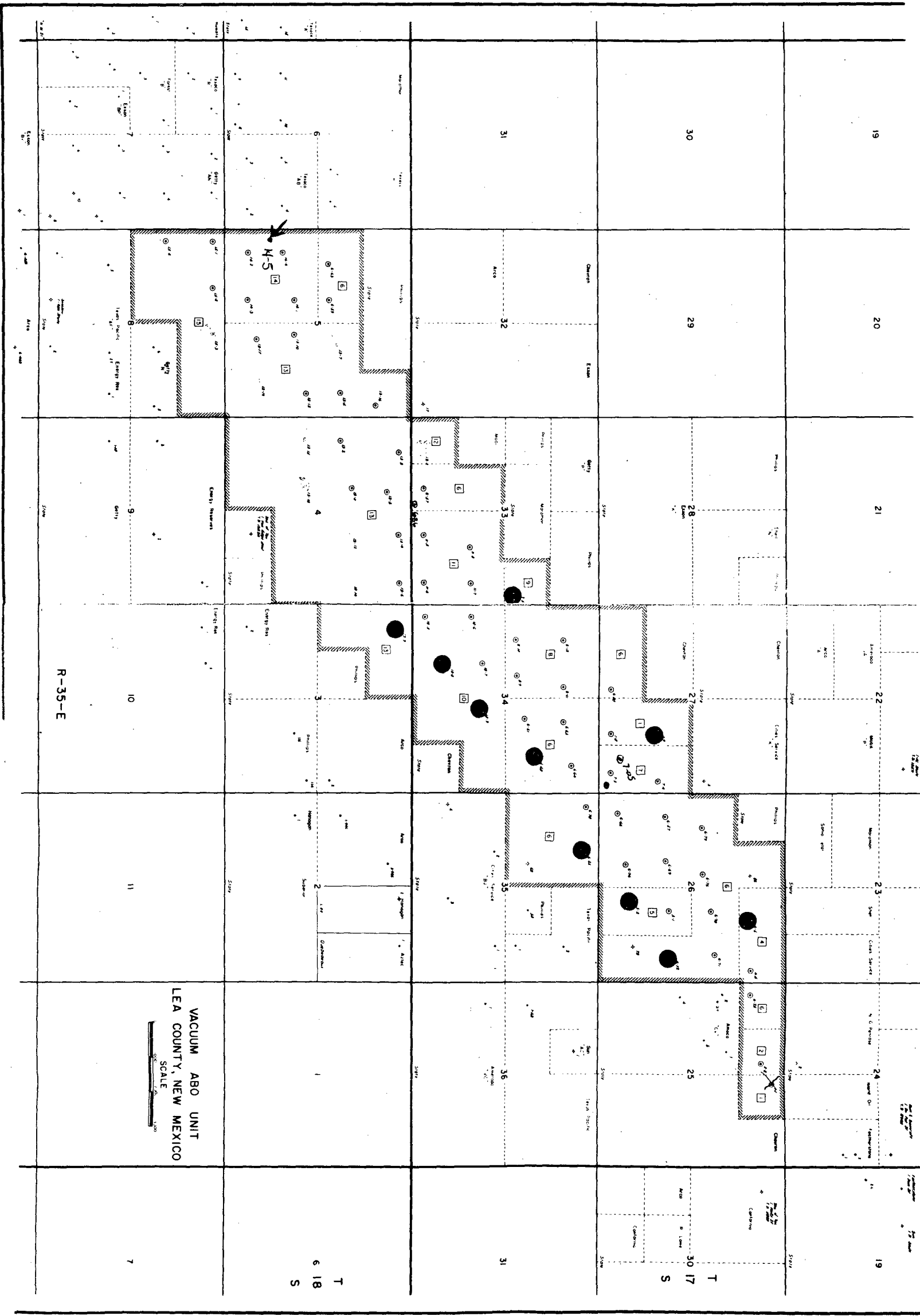
