**AMENDED  
AGREED COMPLIANCE ORDER**

Pursuant to Ordering Paragraph 3 of Inactive Well Agreed Compliance Order 168, the Director of the Oil Conservation Division ("OCD") hereby amends that order as follows:

**FINDINGS**

1. Inactive Well Agreed Compliance Order 168 (ACOI 168) as amended by Inactive Well Agreed Compliance Order 168-A requires XTO Energy, Inc. (Operator) to return to compliance with OCD Rule 201 at least six of the wells identified in the Orders by January 30, 2008 and file a compliance report by that date.

2. ACOI 168 further provides that if Operator returns to compliance with OCD Rule 201 at least six of the wells identified in the Orders by January 30, 2008 and files a timely compliance report, the OCD shall issue an amendment extending the terms of ACOI 168 for a second six-month period, requiring Operator to return an additional six wells to compliance by that deadline. If Operator continues to return wells to compliance at a rate of six wells in each six-month period, the OCD shall continue to issue amendments extending the terms of the Order for additional six-month periods. The total length of the Order, however, shall not exceed two years.

3. Operator filed a timely compliance report, and the OCD has verified that OCD records indicate that Operator has returned the following wells identified in the Order to compliance:



### CONCLUSIONS

1. Operator has returned 32 wells to compliance, exceeding its goal of returning a total of 24 wells to compliance during the four periods of ACOI 168.
2. The OCD should amend ACOI 168 to extend its terms through August 1, 2009. Because Operator has exceeded its compliance goals, Operator does not need to file a compliance report.

### ORDER

1. ACOI 168 is extended through August 1, 2009.
2. Operator does not need to file further compliance reports under ACOI 168.
