Pursuant to Division Rule 104.F(2), BEPCO, L.P. applies for approval of an unorthodox oil well location for the following well:

<u>Well:</u>	Poker Lake Unit Well No. 296
<u>Location:</u>	300 feet FSL & 1200 feet FEL
<u>Well unit:</u>	SE¼SW¼ of Section 32, Township 24 South, Range 30 East, N.M.P.M., Eddy County, New Mexico


The well will be drilled to a depth sufficient to test the Delaware/Bone Spring formation (Nash Draw-Delaware/Bone Spring Avalon Sand Pool). The pool is spaced on statewide rules, with 40 acre spacing and wells to be located no closer than 330 feet to a quarter-quarter section line. A Form C-102 is attached as Exhibit A.

The location was originally orthodox. However, the Bureau of Land Management (the surface/mineral owner) wanted to minimize surface disturbance, and the wellsite is next to an existing lease road additional lease road. See Exhibit B. Also, although not shown on the plat, the wellsite avoids a pipeline in the area. The well was moved south and west of an orthodox location to conform to these matters. Finally, for geophysical reasons, applicant desires to stay in the southern portion of the well unit.

All of Section 32 is covered by State Lease B-10685-1, and the offsetting N½ §5-25S-30E is covered by State Lease B-10678-1. Exhibit C. Besides being fully committed to the Poker Lake Unit, the two leases have common working interest and royalty ownership. Therefore, there is no adversely affected interest owner, and notice has not been given to anyone.
