Dear Sirs:

This is a request for administrative approval to revise the location footages for NSL-4988-B for the Randleman #1N in the Blanco Mesaverde and Basin Dakota pools.

Burlington Resources still plans on drilling and completing the subject well as a Mesaverde / Dakota commingle well. The footages were revised to accommodate the surface owner request to stay off the property line and was adjusted approximately 35' to the west of the previous footage of 690' FNL & 2580' FWL, Sec. 13, T31N, R11W. No other changes were made to the previously submitted NSL application of which NSL-4988-B was approved. This change makes the encroachment approximately 35' less than it previously was and as you mentioned, no further notification will be needed.

When I visited with you this afternoon you gave me instruction on what was needed to adjust the NSL. You also gave verbal approval to drill the subject well as long as we received the revised NSL approval before we first delivered the well. To comply with the instructions I am submitted the following:

- New C102 plat with the correct footages of Unit C, 690' FNL & 2545' FWL, Sec. 13, T31N, R11W
- Copy of the sundry submitted to the OCD in Aztec to adjust their records also

The subject well had to be moved to accommodate the surface owner. It was moved 35' back to the west. The old footages were Unit C, 690' FNL 7 2580' FWL, Section 13, T31N, R11W. **The new footages are 690' FNL & 2545' FWL, Section 13, T31N, R11W.** We talked to David Brooks with NMOCD in Santa Fe and once we submit a letter and new plat he will adjust NSL - 4988-B to the new footages also, since we will be 35' less NSL. He also granted us permission to drill the well, just not produce until the revised NSL is approved. The revised plat is attached.

Also please adjust the footages on DHC - 2734AZ.


