of unorthodox locaitons for the wells listed below:



The proposed infill producers are required to convert a 40-acre five spot pattern within the WAG Area to a 40 acre inverted nine-spot pattern. The 10-acre infill locations will increase the WAG flood efficiency by producing oil currently trapped between adjacent injectors.

All these wells are located within the central portion of the East Vacuum Gb/SA Unit, therefore Phillips Petroleum Company is its own offset operator.
