Mr. Hansen,

On Monday March 10, 2007, NOVA Safety and Environmental (NOVA) on behalf of Plains Pipeline, repaired recovery well RW-1 at the TNM 97-17 (NMOCD reference # AP-017) release site. The recovery well had apparently been struck by an unknown vehicle and damaged. NOVA repaired the casing and the recovery well was reset by a licensed New Mexico water well driller (Mike Holmes). The recovery well was installed on October 23, 2002 and the total depth of the well was 28 feet below ground surface (bgs) on that date. After the repair of the recovery well the total depth is 24.60 feet bgs. On March 11, 2007, the depth to groundwater was 18.23 feet bgs. The new total depth and depth to water will allow for 6.3 foot water column. A Top of Casing (TOC) resurvey will be required for an accurate Groundwater Elevation with regard to Sea Level. Based on the following data, NOVA believes the recovery well is viable and will not required re-installation.

Dear Ms. Reynolds: Upon review of the files for the above referenced site, the New Mexico Oil Conservation Division (OCD) cannot approve the P/A of the damaged recovery well, RW-1. Please repair the well or replace the well to resume recovery activities at the same location. If the well is replaced, the well must be located as close to RW-1 as practicable. In any case, please report to the OCD within 10 days of the option chosen, including a schedule for repair or replacement.

Mr. Hansen,

On February 28 during weekly PSH recovery at the Plains TNM 97-17 release site (A-017) it was discovered that Recovery Well RW-1 had been damaged by an unknown source. RW-1 is located in the middle of the source area and the latest gauging data indicates that RW-1 contains approximately 0.05' of PSH. Recovery is on-going from the surrounding wells (RW-6, MW-15, MW-19, MW-14). Based on the number of recovery wells on-site and the limited amount of PSH in RW-1,
