Mr. Lowe

I talked to Carl Chavez and he instructed that I should contact you. I could not reach you by phone so I am sending this email as the initial notification.

As part of an annual sump and line testing at the BJ Services facility in Hobbs, NM a leak was discovered on one of the facilities drain lines.

This leak was discovered on September 22, 2011 and was found in a long drain line that leads from a lift station within the BJ Services facility across vacant land to the City of Hobbs sewer system.

BJ Services has repaired the leak and we are in the process of conducting soil and water testing on the release.

A letter report will be send to you within the next 10 days detailing more information on the release and the findings of the laboratory analytical results.



Posting at Facility





Posting at Public Place



Posting at Public Place







Within 15-days of completing the above we must:


