ORDER OF THE COMMISSION

This cause came on for hearing at 9 a.m. on February 8, 1967, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this 13th day of February, 1967, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

## FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof or a definition of the subject

(2) That by Order No. R-2440, dated February 28, 1963, Special Rules and Regulations were promulgated for the Indian Basin-Upper Pennsylvanian Gas Pool, Eddy County, New Mexico, for a period of one year from the date of first pipeline connection.

(3) That pursuant to the provisions of Order No. R-2440, this case was reopened to allow the operators in the subject pool to appear and show cause why the Indian Basin-Upper Pennsylvanian Gas Pool should not be developed on 320-acre spacing units.

(4) That the evidence establishes that one well in the Indian Basin-Upper Pennsylvanian Gas Pool can efficiently and economically drain and develop 640 acres. -2-MOIRERENCE MOISAVERENCE LLO SLOTENDE (À CASE No. 2749 DE WER FO ESPÉRIEUR ES Order No. R-2440-A

(5) That the Special Rules and Regulations promulgated by Order No. R-2440 have afforded and will afford to the owner of each property in the pool the opportunity to produce his just and equitable share of the gas in the pool.

(6) That in order to prevent the economic loss caused by the drilling of unnecessary wells, to avoid the augmentation of risk arising from the drilling of an excessive number of wells, to prevent reduced recovery which might result from the drilling of too few wells, and to otherwise prevent waste and protect correlative rights, the Special Rules and Regulations promulgated by Order No. R-2440 should be continued in full force and effect until further order of the Commission.

## IT IS THEREFORE ORDERED:

(1) That the Special Rules and Regulations governing the Indian Basin-Upper Pennsylvanian Gas Pool, promulgated by Order No. R-2440, are hereby continued in full force and effect until further order of the Commission.

(2) That jurisdiction of this cause is retained for the many of such further orders as the Commission may deem neces-
