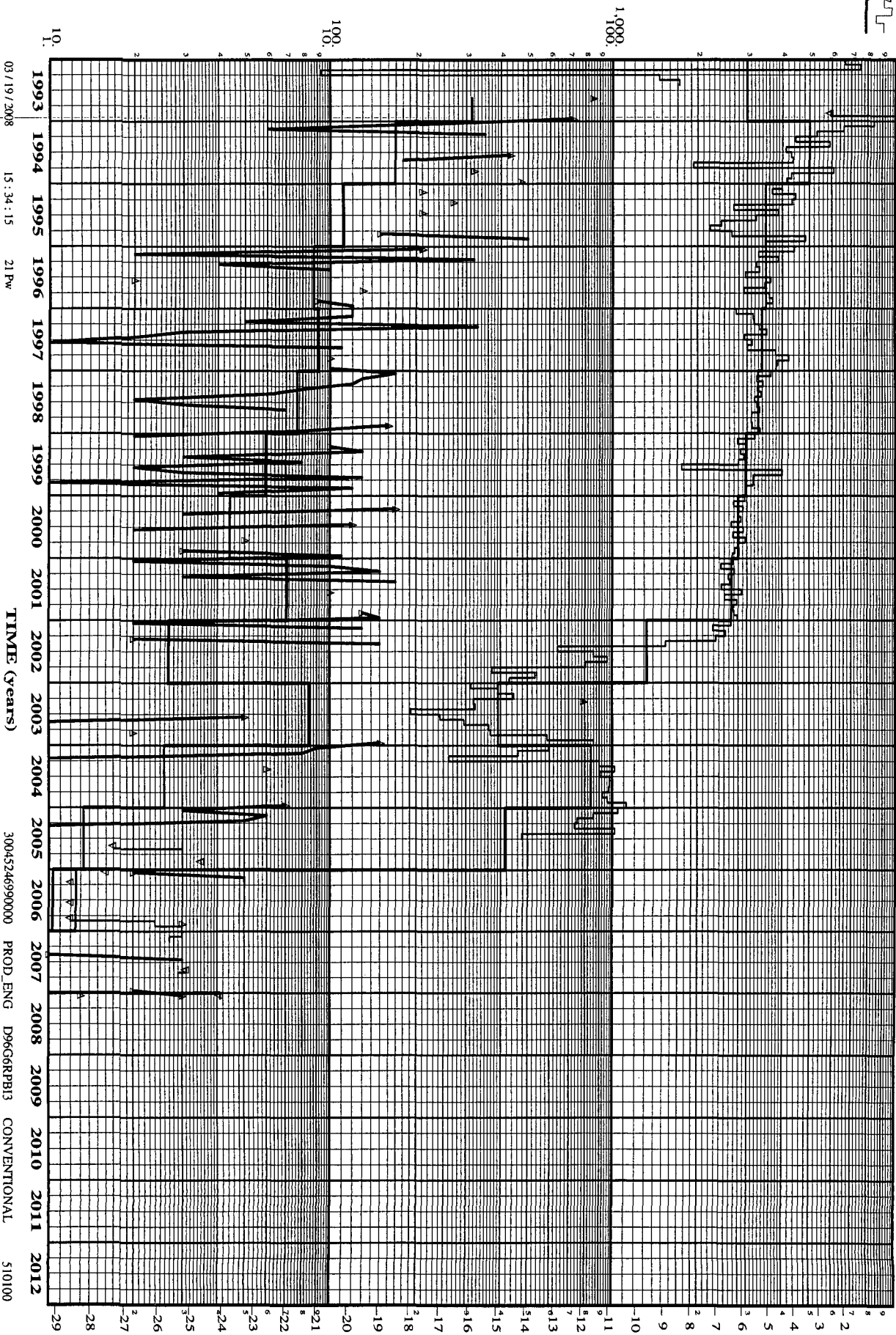

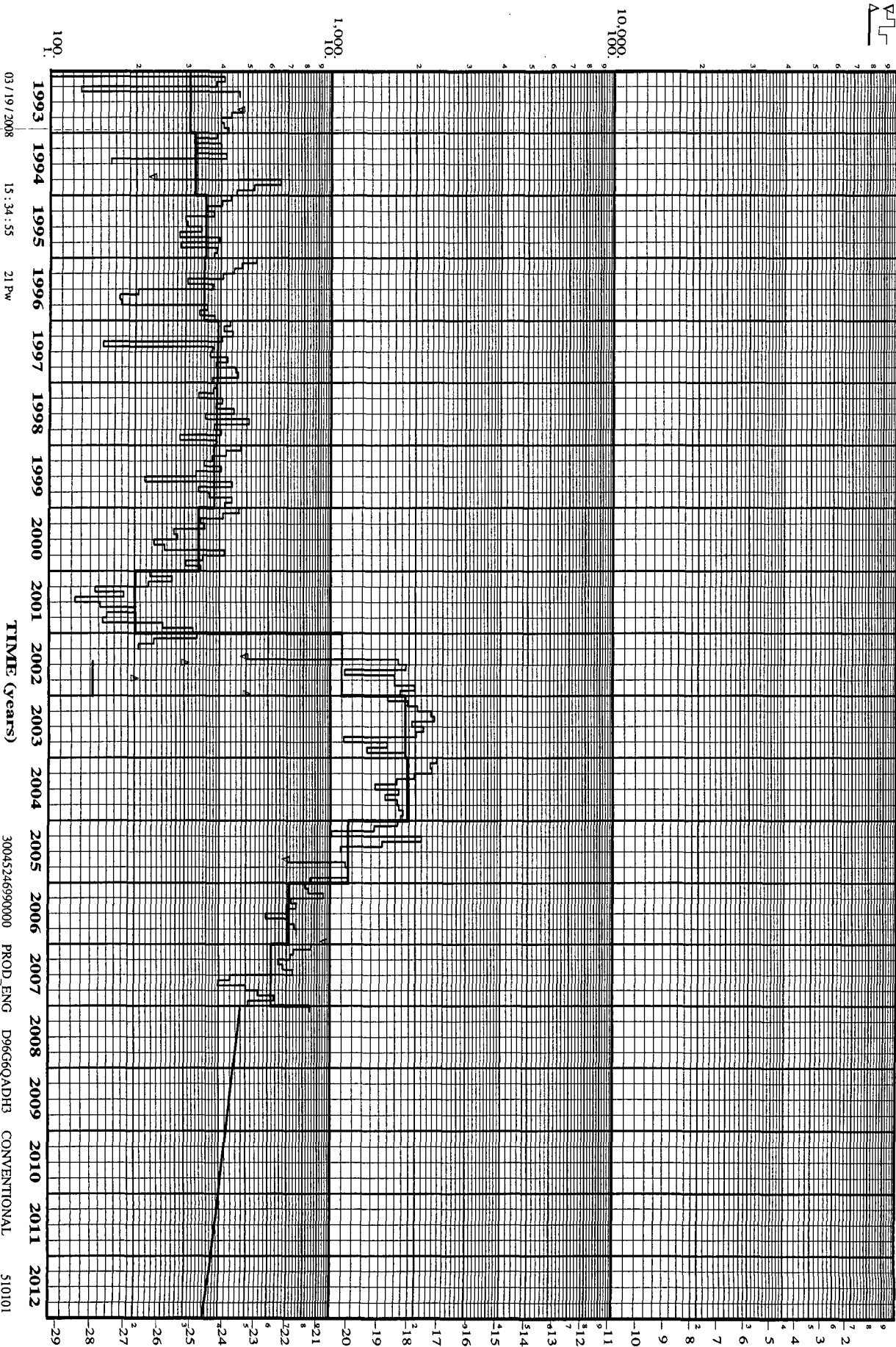

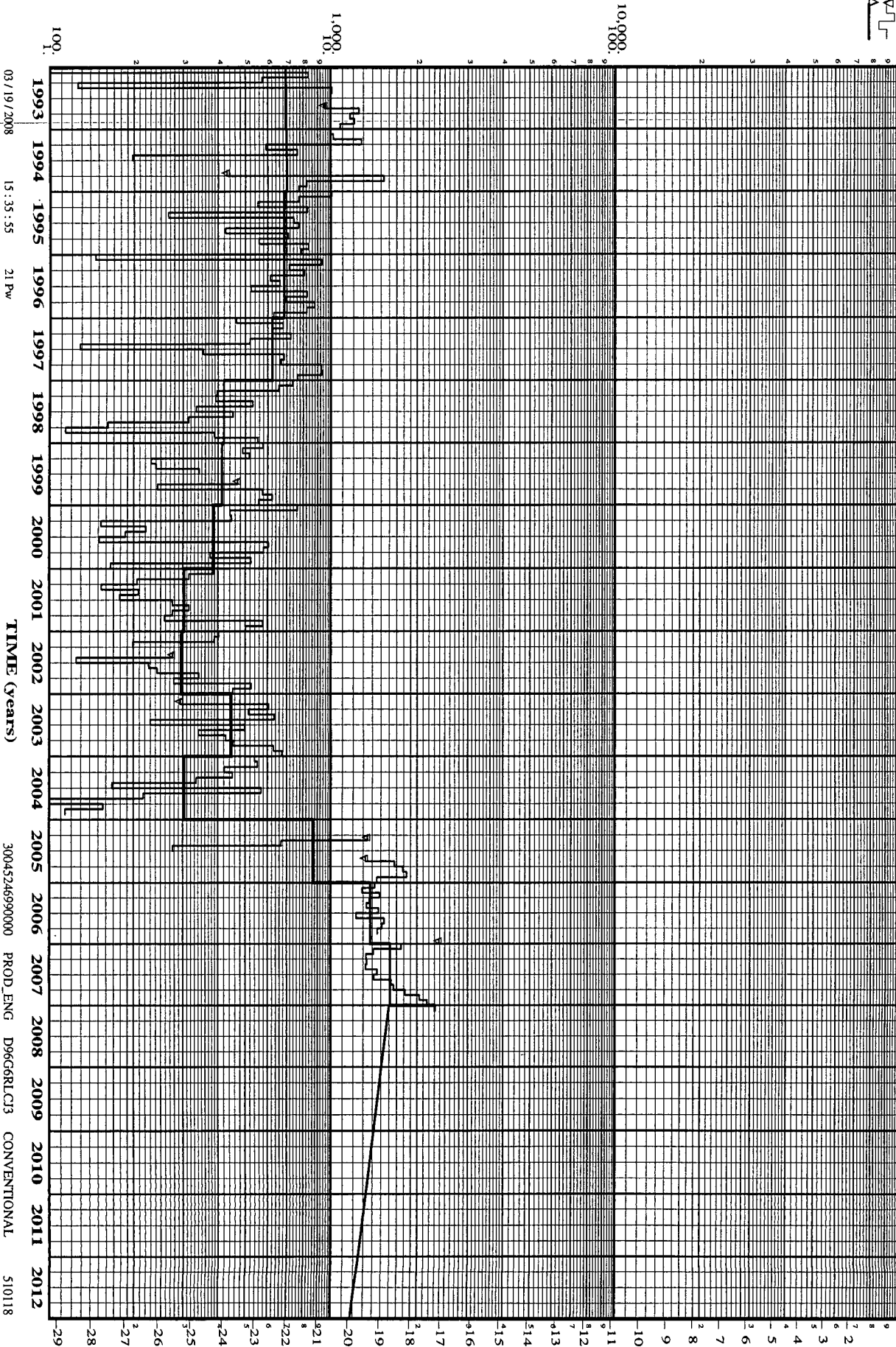

XTO Energy Inc would like to submit an application to the New Mexico Oil Conservation Division (NMOCD) to downhole commingle production from the the Blanco Mesaverde, the Aztec Pictured Cliffs and the Farmer Fruitland Sand pools in the Aztec #9. This well failed the packer leakage test and NMOCD has required us to repair it. The well also failed its test in 2005 and was required to be repaired at significant cost; therefore, XTO is recommending removing all plugs and downhole commingling thus, eliminating need for future packer tests and potential repair. Commingling of these pools will minimize operating costs, add reserves and improve economics of the well.

The proposed allocation percentages for each pool are based on cum production through October, 2007 and are as follows:

Farmers Fruitland Sand	Gas: 17.14%	Water: 39.67%	Oil: 0.00%
Aztec Pictured Cliffs	Gas: 12.74%	Water: 26.89%	Oil: 1.64%
Blanco Mesaverde	Gas: 70.12%	Water: 33.44%	Oil: 98.36%

NMOCD requires all interest owners be notified of intent to downhole commingle if ownership is different between zones.
