General Description of Remedial Action:

This junction box was addressed as part

of the Vacuum SWD System abandonment. After the box lumber was removed and the pipelines were capped, a delineation trench was made at

the site to collect soil samples. Chloride field tests were conducted on the samples and yielded very low concentrations similar to those of the

background sample. Organic vapors were measured and also yielded very low concentrations. The grab samples from the deepest part of the

trench (6 ft) was sent to a laboratory for confirmation and TPH analysis. TPH and chloride concentrations were not detected in the sample.

The excavated soil was returned to the trench and the remainder of the hole (from removal of the junction box) was backfilled with clean, imported

soil which was also spread on the surface to encourage regrowth. The surface was seeded with a blend of native vegetation on 8/23/2007 and is

expected to return to productive capacity at a normal rate.
