Marbob Energy Corporation respectfully requests an administrative approval without notice and hearing of an unorthodox well location pursuant to Rule 104, Section F (1) of the New Mexico Oil Conservation Division. The well location legal description is as follows:

Burch-Keely Unit No. 223

1365 feet from the East line,
2000 feet from the North line
Section 23, Township 17 South,
Range 29 East, Eddy County, New Mexico

The well will be completed in the Grayburg San Andres formation in the Grayburg Jackson Seven Rivers Queen Grayburg San Andres Pool.

Attached to the application are the following Exhibits:


- A. Well location and Acreage Dedication Plat (form C-102) filed with the Carlsbad office of the Bureau of Land Management. (Exhibit A)

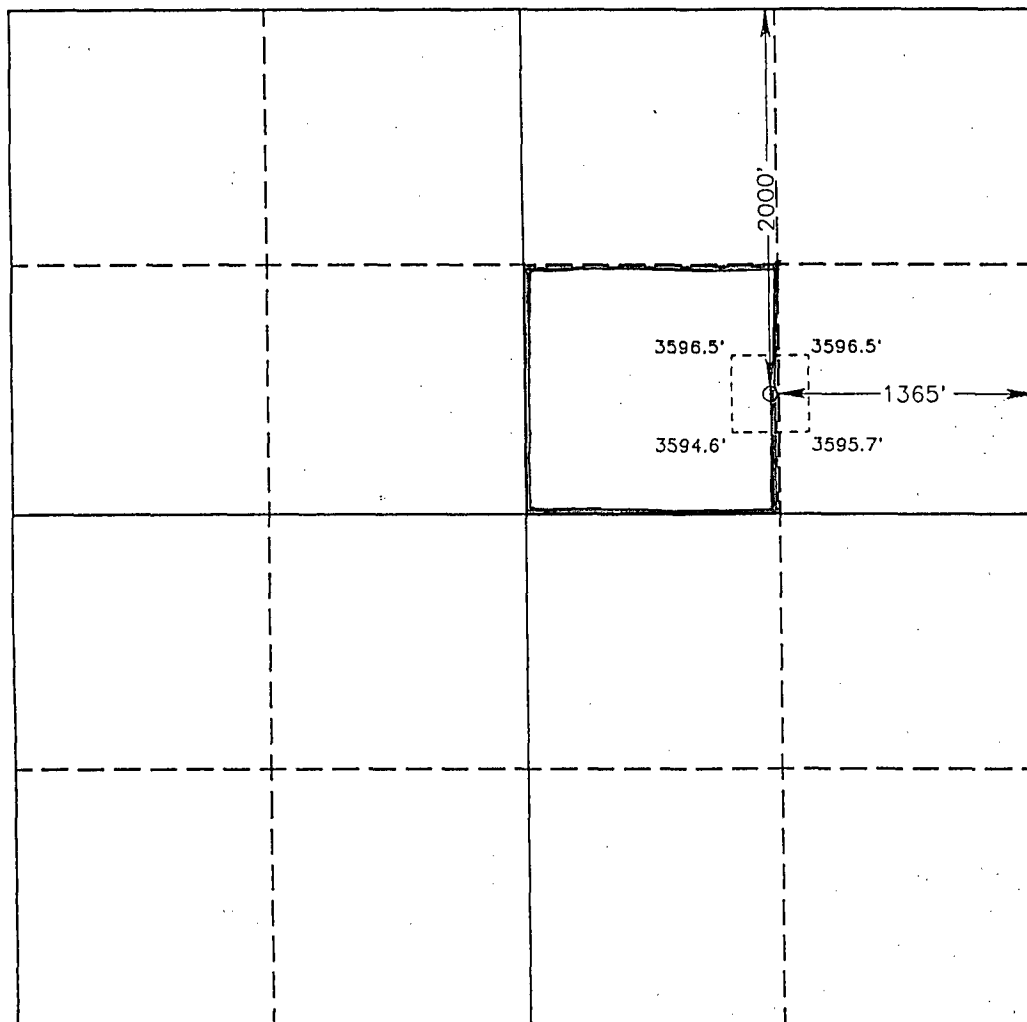
