

Application for Unorthodox Location Florance Gas Com A #1R Well NE/4 Section 22-T30N-R8W Basin Fruitland Coal Pool San Juan County, New Mexico

Amoco Production Company hereby requests administrative approval for an unorthodox location in the Basin Fruitland Coal Pool. Amoco proposes to drill the Florance Gas Com A #1R Well at a location 760' FNL and 570' FEL of Section 22. The Florance Gas Com A #1R Well will be a replacement well for the original Florance Gas Com A #1 Well drilled in 1989. During completion of the original well, a cavitation procedure was attempted. This procedure was not successful and a liner was cemented in the open hole and the well was fracture stimulated. The well has been unable to produce more than 20 MCFD and is currently shut-in. This unorthodox location is necessary due to the topography and archeological constraints in this area. Attached is a topographical map and letter from the Bureau of Land Management supporting the need for this location. This spacing unit is in the E/2 Section 22, T30N-R8W. The offset operator will receive a copy of the application by certified mail with a request that they furnish your Santa Fe office with a waiver of objection and return one copy to Amoco.







Dear Mr. Schwarz:

This is in reference to your Notice of Staking for the Florance Gas Com. A#1R, 760' FNL, 570' FEL, Sec. 22, T. 30 N., R. 8 W., Lease No. SF-078578. After working to find a suitable location within the windows established by the New Mexico Oil Conservation Commission, we suggest you submit for a non-standard location. A suitable location and access road was not found due to topography and archaeological constraints. The proposed well pad is located on a fairly flat pinon-juniper covered bench, midway between valley floor and ridge top. This bench is wide enough to accommodate a 300 ft. X 265 ft, pad without large amounts of cuts and fills and no additional access needing to be constructed. This location approximately 600 ft. to the northeast of the originally staked location would be most suitable. This area does not affect the bench system in the area, and there is existing access roads.


In the past we have discussed that non-standard locations would probably be proposed more frequently as the more desirable locations are developed. It is our desire to find the best possible locations for new wells and access roads being proposed with minimal environmental impacts. Therefore, we will be glad to support your non-standard proposal for the Florance Gas Com. A#1R to the NMOCC.


