Dear Ms. Davidson:

Synergex, Inc., successor by name change to Bledsoe Partners, Inc., is the operator of the Dark Canyon Unit comprising all of Section 18, Township 23 South, Range 25 East, Eddy County, New Mexico.

The purpose of this letter is to request administrative approval of an unorthodox located 660' from the north line and 660' from the west line of Section 18 pursuant to Rule 104 of the Rules and Regulations of the Oil Conservation Division of the State of New Mexico. This unit is composed entirely of Federal leases and originally produced from the Morrow formation. Production ceased from the Morrow and the communitization agreement was terminated. The leases are extended through April, 1996. Plans are to re-enter the well and test the Strawn/Canyon formations between the depths of approximately 8,500 to 8,600 feet.

Approval was originally granted for an unorthodox location for the Morrow formation by Order of the Oil Conservation Division dated December 3, 1974, in Case No. 5373, Order No. R-4933. A copy of that Order is attached.

The attached plat sets forth the ownership of the offset leasehold and the producing wells on such leasehold. The only producing well on any of the six sections is the Rock Tank #1 located in the northwest quarter of Section 7. The Rock Tank Unit is a 2,285 acre unit which produces from the Morrow formation. Ownership of the South Half (S½) of Section 18 is common with the North Half (N½).

The Strawn/Canyon formations are currently not spaced in Section 18. If productive, the unit will consist of the North Half (N½) of Section 18. The Communitization Agreement is currently being circulated.

Notice is being mailed to each of the offset leasehold owners and to the non-operators in the Rock Tank Unit, notifying them of this application as required by the applicable rules and regulations. A copy of the notice and certified mail receipts is included.

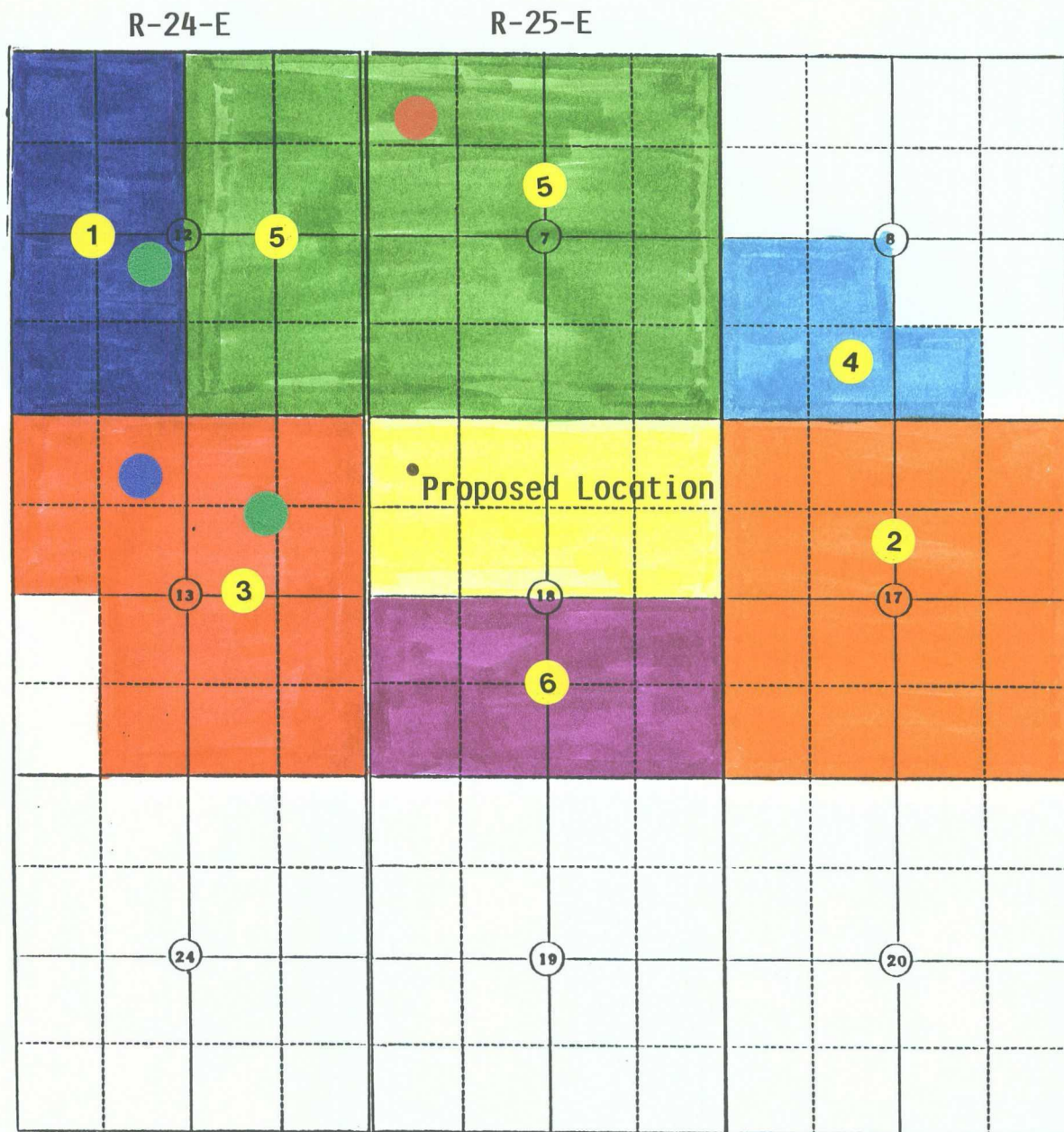

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on November 26, 1974, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this 3rd day of December, 1974, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, Monsanto Company, seeks approval of an unorthodox gas well location to test the Morrow formation at a point 660 feet from the North line and 660 feet from the West line of Section 18, Township 23 South, Range 25 East, NMPM, Rock Tank Gas Field, Eddy County, New Mexico.

(3) That all of said Section 18 is to be dedicated to the well.

(4) That a well at said unorthodox location will better enable applicant to produce the gas underlying the proration unit

(5) That no offset operator objected to the proposed unorthodox location.

(6) That approval of the subject application will afford the applicant the opportunity to produce its just and equitable share of the gas in the subject pool, will prevent the economic loss caused by the drilling of unnecessary wells, avoid the augmentation of risk arising from the drilling of an excessive number of wells, and will otherwise prevent waste and protect correlative rights.



(2) That all of said Section 18 shall be dedicated to the above-described well.



Reference is made to Administrative Order NSL-3597 (NSP) in your correspondence dated November 14, 1995, to Synergex, Inc. of Oklahoma City, Oklahoma (copy enclosed). In said letter you advised Synergex, Inc., as then operator of the Dark Canyon well no. 1 (API 30-015-21439), that the previously approved non-standard gas well location at 660' from north and west lines of Section 18, T-23-S, R-25-E, NMPM, Eddy County, New Mexico, was therein approved for additional spacing and pooling requirements in the then requested Canyon/Strawn formations.

ICA Energy, Inc. has purchased and succeeded to all leasehold interest of Synergex, Inc. (also known as Bledsoe Petro Corporation and Bledsoe Partners, Inc.) of federal leases NM-0100958 and NM-0100958-A covering the N/2 of said Section 18, effective February 1, 1996.

ICA and its operating affiliate, Mineral Technologies, Inc. of Midland, Texas ("MTI"), is proposing to reenter the Dark Canyon well for the purposes of re-completion of production in commercial quantities in order to facilitate lease maintenance on the subject property. As the lease is currently in a two year extension provision from the BLM and inasmuch as the subject leases will terminate on April 11, 1996, pending actual production from the subject wellbore, ICA requests your immediate concurrence of approved location and formation spacing for ICA/MTI to attempt to recomplete either the Morrow, Canyon or Strawn formations accordingly. ICA is going to attempt to establish production from one of these three zones, it being understood that the spacing and designation for the Morrow having previously been approved by your Commission, in the subject property. Failing reestablishment in the known Morrow ICA will, of course, attempt a recompletion in the Canyon/Strawn and as we believe that your previous correspondence and order dated November 14, 1995, is approved, we do ask you to, once again, ratify same for our records accordingly.
