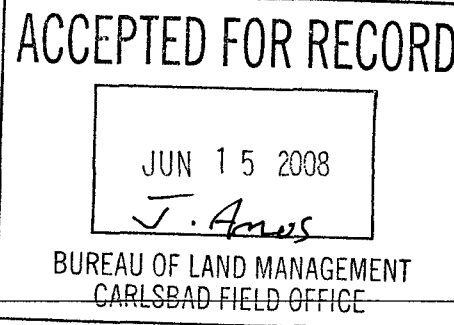

13. Describe Proposed or Completed Operation. Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Drilled 12-1/4" hole to 3,492'. Ran 9-5/8", 36#, J-55 casing. Landed with shoe @ 3,389', float collar @ 3,349'. Cemented with 1,335 sx. 35/65 Poz/C and additives (1.97 yield and 12.6 ppg) followed by 200 sx. Class C and additives (1.33 yield and 14.8 ppg). Displaced cement and bumped the plug. Circulated 200 sx. cement to surface.

Nipple down 13-5/8" BOP. Cut off 13-3/8" wellhead. Welded on 11", 3,000# head and nipped up 11", 3,000 psi. BOP. Tested BOPE. Picked up bit and BHA. Drilled out shoe 28-3/4 hrs. after cement in place.
