Based on safety concerns with regards to DCP's pipe being exposed to the elements and elevated by pipeline stands across the J-4-2 excavation, DCP will move forward with backfilling the excavation with clean borrow material to protect the pipeline. A poly liner will be installed along the base of the excavation before the backfill activities commence. Once the excavation is backfilled, DCP will submit a soil closure report to the OCD. DCP will continue to conduct the quarterly groundwater monitoring at the site.

American Environmental Consulting, LLC, a subcontractor to DCP Midstream (DCP), will complete groundwater monitoring activities at the DCP J-4-2 site. The project site is located in Unit C, Sec 27, Township 19S, Range 35E. Coordinates are 32.647 north, 103.447 west, Lea County

The activities to be completed include:

1. Measuring fluid levels in all monitoring wells associated with the study area.
2. Purge a minimum of three casing volumes from monitoring wells that do not contain free product. Continue purging as necessary until the field temperature, pH and conductivity stabilize.
3. Collect groundwater samples for BTEX and chlorides from the purged wells.
4. Dispose of all affected purge water at the DCP Linam Ranch facility.

The activities will begin on September 17, 2008 no earlier than 0800 MDT.
