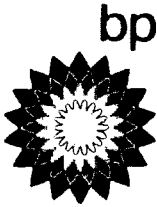

AP America Production Company respectfully requests an administrative approval for a non-standard well location for the Hughes A Well No. 3N to be drilled at a location of 540' FSL and 940' FEL of Section 28, T29N-R08W. The non-standard location is necessitated by topographical conditions and would insure the conservation of surface and subsurface resources in the area.

Cutter Dam as shown on Attachment APD 2 encompasses the majority of the acreage within Section 28 and prohibits the drilling of a well at a standard location within east half of the section. To aid in your review attached is a C-102 Well Location Plat showing the well location, a topographical map (APD Map # 1), a 9 section plat showing the offset wells and operators and copy of an Ariel photo with the well location indicated.

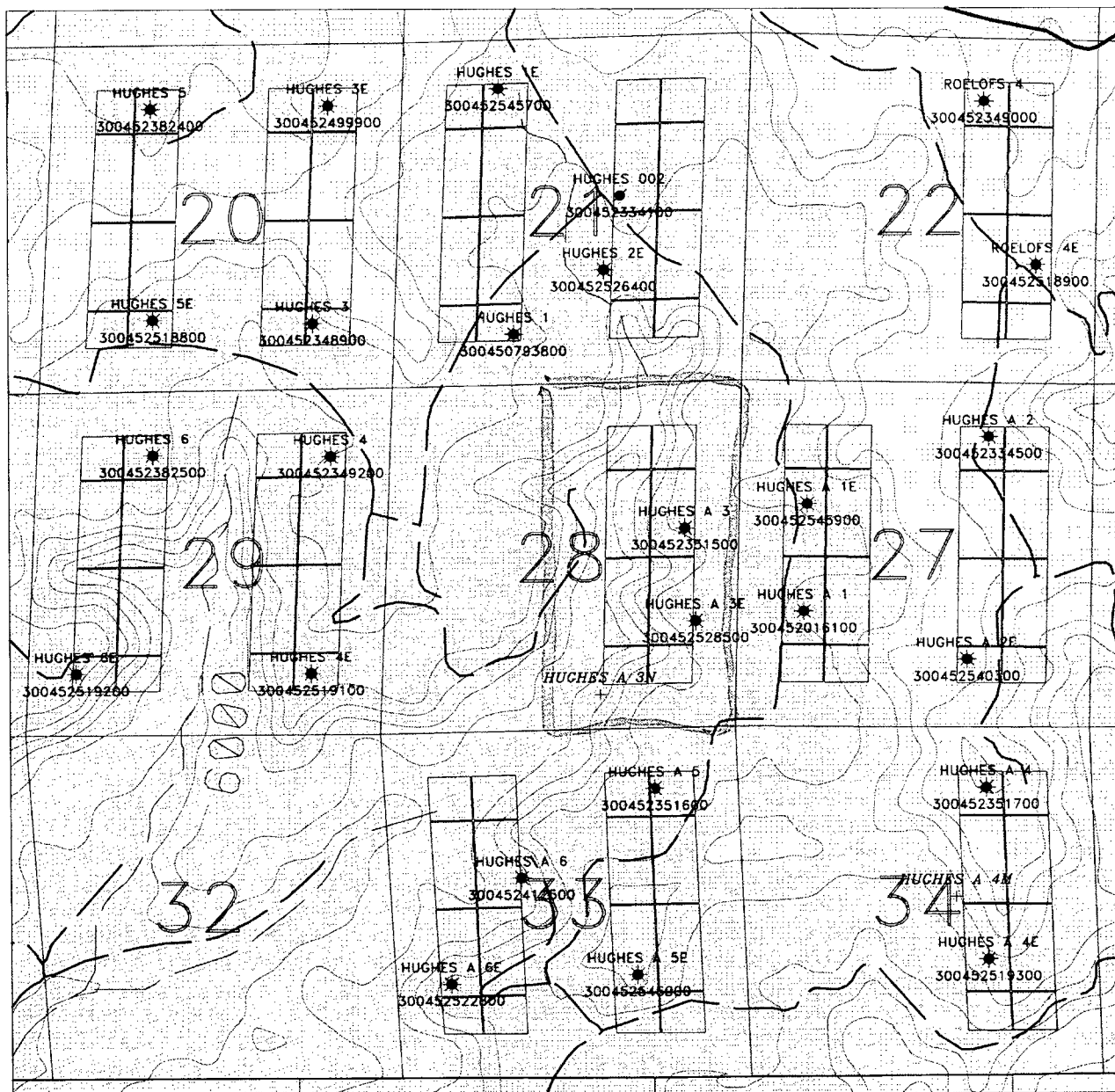
