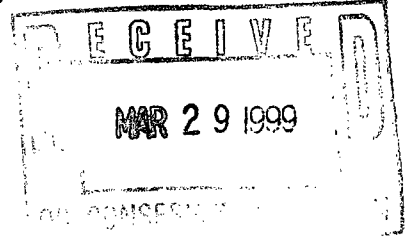

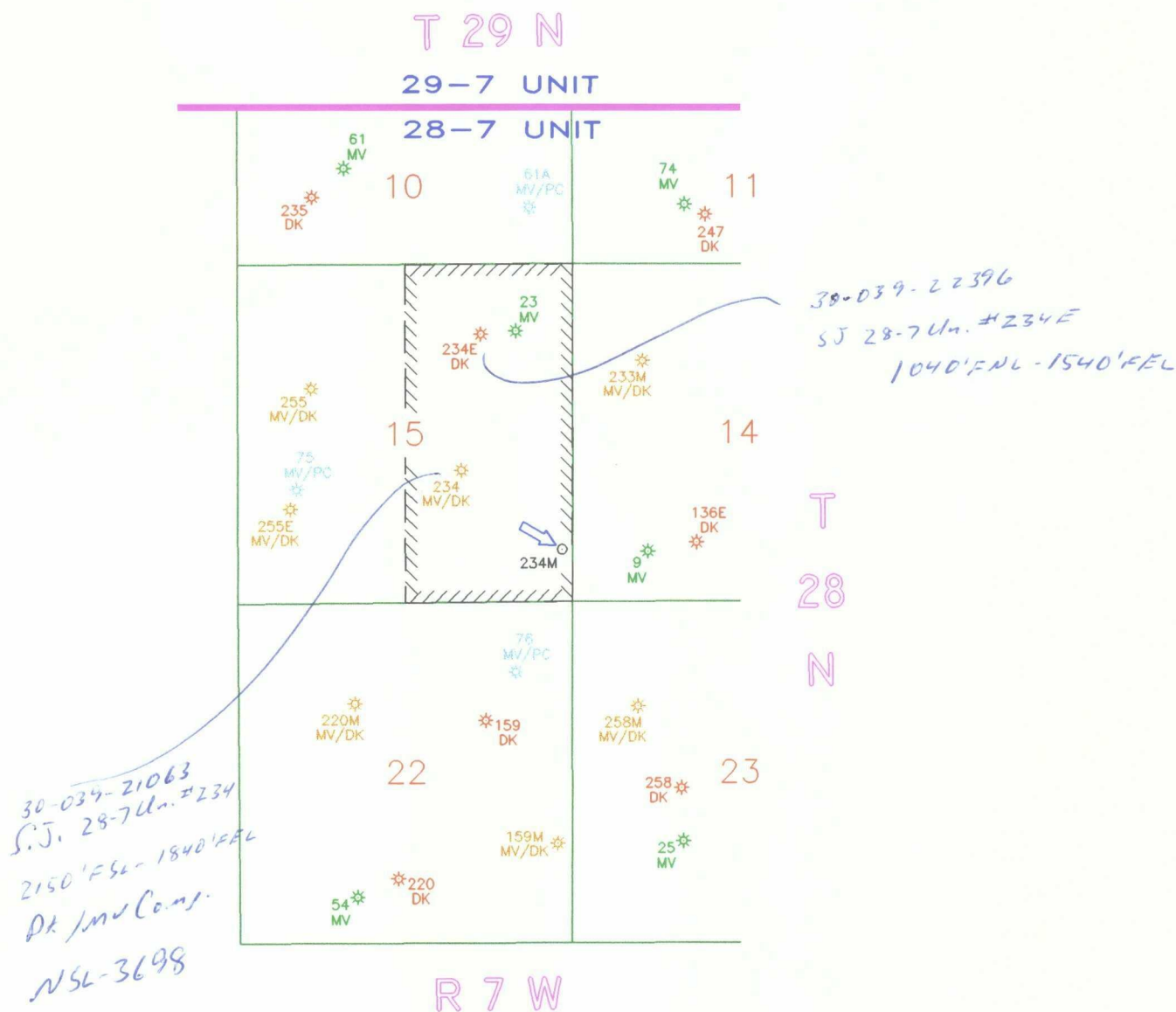
Conoco Inc plans to drill the above referenced well in 1999. The Basin Dakota pool rules state that this well must be 790' from the section lines. This well is staked 805' FSL and 160' FEL. This location places the well only 160' from the east section line thereby requiring this application for a non-standard location order. The referenced location is an open, 160 acre Dakota infill site authorized for drilling by Order # R 11139. Initially a standard location was staked however this location proved inaccessible due to topographic problems. The new location has been field checked and approved by the BLM and will not compromise the validity of information that proposed the drilling of this 80 acre Dakota pilot infill well. Please note that the location is interior to the 28-7 unit, and does not encroach on any unit boundaries. Conoco is the sole operator of the 28-7 unit therefore they are the only offset operator. An application to downhole commingle (C107A) the Blanco Mesaverde and Basin Dakota was submitted February 20, 1999 referencing the previous standard location. Upon approval of this non-standard location request we will notify the appropriate parties as to the amended location.

Conoco, respectfully requests that a non-standard location for the Basin Dakota Pool be issued for the referenced well for the reasons cited above. If there are any questions concerning this application, please feel free to call me at (915) 686-5798.

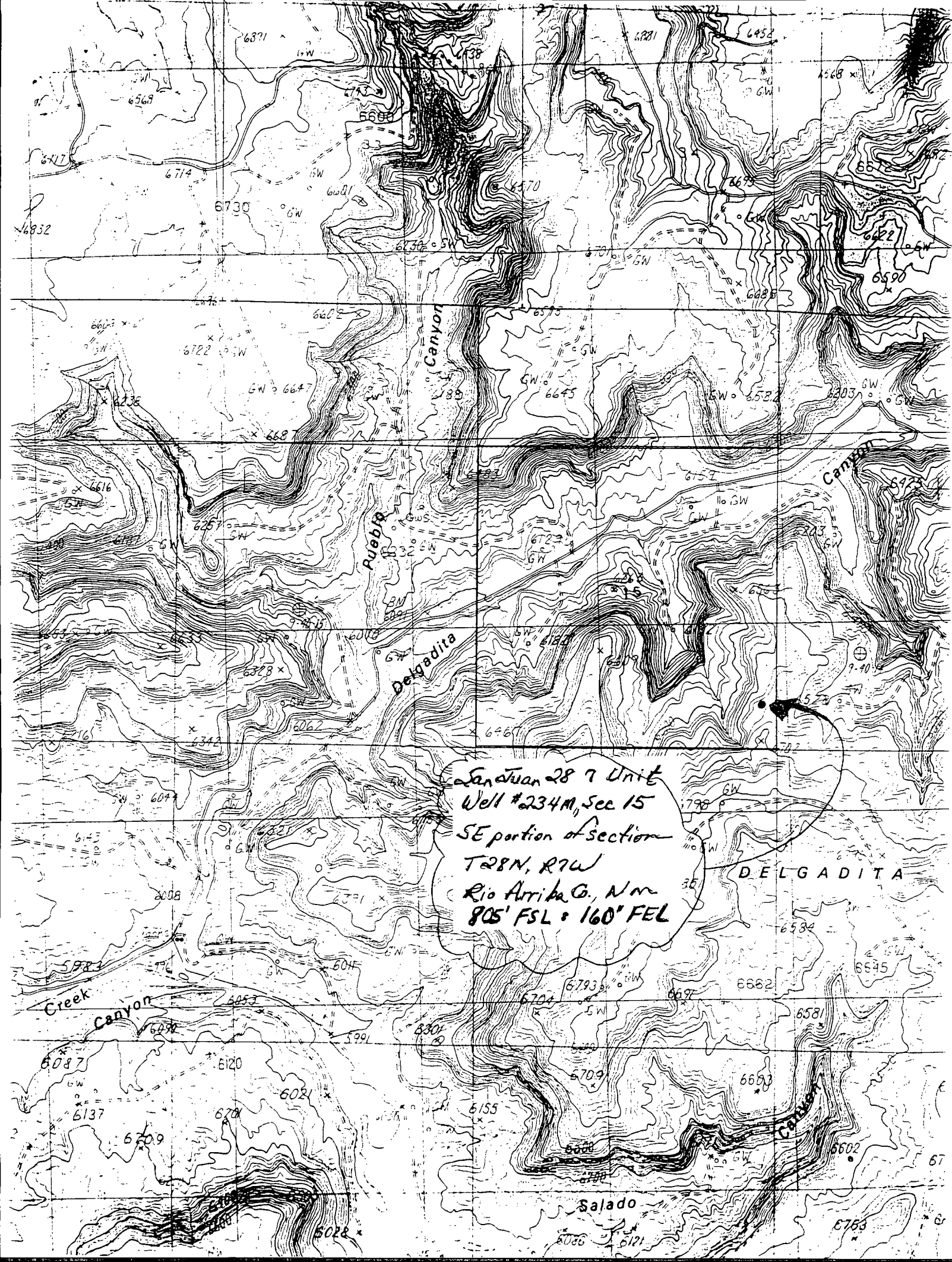


Dear Mr. Hoover:

Reference is made to your application dated August 16, 1996 for an unorthodox gas well location for both the Blanco-Mesaverde and Basin-Dakota Pools for the existing San Juan "28-7" Unit Well No. 234 (API No. 30-039-21063) located 2150 feet from the South line and 1840 feet from the East line (Unit J) of Section 15, Township 28 North, Range 7 West, NMPM, Rio Arriba County, New Mexico.

Production from both pools in said well is to be included to the existing standard 320-acre gas spacing and proration units comprising the E/2 of said Section 15, which the Mesaverde production is currently dedicated to Conoco's San Juan "28-7" Unit Well No. 23 (API No. 30-039-07433), located at a standard gas well location 990 feet from the North and East lines (Unit A) of said Section 15 and the Dakota production is currently dedicated to Conoco's San Juan "28-7" Unit Well No. 234-E (API No. 30-039-22396), located at a standard gas well location 1040 feet from the North line and 1540 feet from the East line (Unit B) of said Section 15.

By the authority granted me under the provisions of Rule 2(d) of the "Special Rules and Regulations for the Blanco-Mesaverde Pool" and the "Basin-Dakota Pool", as promulgated by Division Order No. R-8170, as amended, the above-described unorthodox gas well location is hereby approved.
