Dear Mr. Arline:

Reference is made to your application dated December 30, 1996 for a non-standard Grayburg oil well location for the existing Grayburg Jackson San Andres Unit Well No. 42 (**API No. 30-015-21829**), to be redesignated the Stevens "A" Well No. 5, which was drilled in 1976 to a total depth of 3,460 feet and completed at a previously approved unorthodox oil well location (see Division Order No. R-5206, dated April 27, 1976) in the Windfohr Grayburg-Jackson Waterflood Project, established by Division Order No. R-3257, dated June 8, 1967 for the purpose of completing an efficient production/injection pattern within said waterflood area, 1295 feet from the South line and 25 feet from the West line (Unit M) of Section 13, Township 17 South, Range 30 East, NMPM, Grayburg Jackson (San Andres) Unit Area, Eddy County, New Mexico.

It is our understanding that said well is to be recompleted from the unitized San Andres formation of the Grayburg-Jackson Pool to the non-unitized Grayburg portion of said Pool and pursuant to **Rule 104.C(1)(a)** of the General Rules and Regulations of the New Mexico Oil Conservation Division ("Division"), revised by Division Order No. R-10533, issued by the Oil Conservation Commission in Case 11,351 on January 18, 1996, said well location is unorthodox. Further, the SW/4 SW/4 of said Section 13 shall be dedicated to the well forming a standard 40-acre oil spacing and proration unit.

The application has been duly filed under the provisions of Division General **Rule 104.F**; therefore, by the authority granted me under the provisions of Division General **Rule 104.F(2)**, the above-described unorthodox Grayburg oil well location is hereby approved.

That portion of said original Order R-5206 approving the unorthodox San Andres oil well


