
Describe Cause of Problem and Remedial Action Taken.*

Livestock in the area entered the barb wire fenced tank battery and subsequently parted a circulating line from the back of the 210 bbl oil storage tank on location. The valve was then kicked open emptying the tank. Remedial action involved locking valve handles in facility and reconstructing fencing.

Describe Area Affected and Cleanup Action Taken.*

The affected area is contained in a 50' x 25' tract. The affected soil will be removed and taken to an OCD approved land farm. Surface soil samples will be taken and checked for hydrocarbon contamination. Fresh topsoil will be purchased from the landowner, hauled in, and contoured over the area. Earthen berms will be built around the tank battery and covered with a liner.

The New Mexico Oil Conservation Division District 2 Office (OCD) is in receipt of a C-141 including a work plan proposal (plan) for remediation of the release of crude oil that occurred at the above referenced facility. The C-141 proposes the affected soils will be removed and taken to disposal. Soil samples are to be obtained and analyzed for hydrocarbon contamination.


The plan is accepted with the following stipulations:

- Notify the OCD 48 hours prior to obtaining samples where analyses are to be submitted to the OCD.
- Provide OCD a copy of analytical results **prior** to any backfilling activities.
- Submit a Final Report Form C-141 upon satisfactory completion of activities.
- Remediation requirements may be subject to change as site conditions warrant.
- Remediation to be completed on or before **October 21, 2008**.
