General:

Leak occurred 8/25/08, notice was given to OCD immediately. Vacuum trucks were on location and began cleaning up. All fluids available were picked up and hauled to Sundance Disposal. We recovered approximately 128 bls. Valve in tank was replaced and cleanup around tank and drive area was started.

Groundwater:

According to the State Engineers records, groundwater occurs at a depth of approximately 30 ft. The groundwater in this area has elevated chloride of approximately 2000 ppm.

Cleanup Proposal:

Sample area for BTEX, TPH and Chloride. Excavate spill area until a cleanup level approved by the OCD is achieved. Install a clay barrier at bottom of excavation, backfill and level, only after OCD approves.

Cleanup level based on groundwater 100 ppm TPH.

All analysis, photos and report will be sent to the OCD.

We will notify the OCD of all activities. If this meets with your approval, we will begin immediately.
