This is a request for administrative approval to recomplete our Cossatot M Well No. 2 in the Abo as an unorthodox location. This well was approved as a unorthodox location September 16, 1975 under Administrative Order NLS-722. (Copy attached.) The well was completed as a Wantz Granite Wash completion 6273 (Copy 30) (273)

The Wantz Granite Wash is now uneconomic and we wish to recomplete the well in the Abo. The reasons necessary for unorthodox location were the following:

1. A railroad track runs in a northwest to southeast direction across the center of this 40 acre tract.

2. There are three wells located on this 40 acre tract to the west of the railroad. This being the John H. Hendrix Corporation's Thomas Long No. 2, (the well is not deep enough to test the Abo, plus the working interest is different than the Abo rights in the subject well.) There are also two plugged and abandoned wells west of the track, the R. L. Parker's No. 2, a plugged and abandoned well, and the John H. Hendrix Corporation Paddock Unit No. 89, a plugged and abandoned well.

3. There are two oil pipelines running east-west across the 40 acre tract plus numerous other flow lines.

4. John H. Hendrix Corporation is owner of the Abo rights in the 160 acres of the SW/4 of Section 11, T22S, R37E. The royalty interest in the 160 acre quarter section is also the same. No offset operators are being affected by this unorthodox location for recompletion in the Wantz Abo.

Also attached is the original C-102, a current C-102 to recomplete to the Wantz Abo, a map showing the 160 acre Wantz Abo rights and a Form C-101 on the Cossatot M No. 2 well.
