**Edward,**

Given below is a quarterly update (through 3rd quarter, 2008) for the above-referenced Rice Operating Company Projects, EME C16(1) and EME C16(2), respectively.

We have been recovering groundwater at the above referenced sites since July of 2008 per the respective Corrective Action Plans. To date we have recovered and treated (using reverse osmosis) approximately 83 bbls of water collectively from the central wells at both locations (see attached graph). This water has been used to irrigate the affected pipeline right of way to facilitate ecological restoration.

We plan to shut this system in over the winter due to the impossibility of keeping from freezing and damaging the equipment, and we anticipate restarting during the 1st quarter or early 2nd quarter of next year when the likelihood of severe frost has passed.
