


Describe Cause of Problem and Remedial Action Taken.* A six inch asbestos cement line cracked. Pipeline was clamped.

Describe Area Affected and Cleanup Action Taken.*

Approximately 1,892 square feet was affected. Areas that were highly impacted were excavated to 3 feet. Field samples were taken and sent to a laboratory for confirmation. All excavated soils were blended to below 250 ppm chlorides. The excavation was backfilled and contoured to the surrounding terrain, and the site was seeded.
