Oil and gas production from the Hardy 36 State Well No. 28 shall be continuously metered separately from oil and gas production from the remainder of wells producing by this operator on this lease. Periodic well tests shall be used to allocate production from other wells within this lease.

It is our understanding that all wells and pools within Section 36, except for well No. 28 as producing from the North Hardy-Strawn Pool, are of identical ownership. It is also our understanding that all interest owners involved in this proposed commingle have been notified and have not objected.

It is the responsibility of the producer to notify the transporter of this commingling authority. The operator shall notify the Hobbs District Office of the Division upon implementation of commingling operations.

As per Division Rule 303B.(1)(b), if federal, Indian or state lands are involved, the United States bureau of land management or the commissioner of public lands for the state of New Mexico (as applicable) shall be notified of the proposed commingling prior to this order being valid.

NOTE: Commingled production shall be stored at the Hardy "36" State Lease tank battery, located in the NE/4 SW/4 of Section 36, Township 20 South, Range 37 East, NMPM, Lea County, New Mexico.
