


Describe Cause of Problem and Remedial Action Taken.* A full investigation will be completed; however, based on initial observations, the release was a result of a crack in the thread seam of a 1/2 in. x 3 in. steel nipple connecting a tube to the suction side of an IMO pump. The crack, which appears to be from about the noon to eight o'clock position, resulted in a spray of crude oil from the tube. The release lasted approximately 24 hours. The pump was shutdown upon confirmation of the release and a vacuum truck was dispatched to the location collecting approximately 3 bbls of crude oil. Plastic has been placed along the ConocoPhillips right-of-way and the process of moving visually contaminated soil onto the plastic has begun.

Describe Area Affected and Cleanup Action Taken.* The area directly impacted by the release is approximately 90ft x 100 ft in the area immediately adjacent to and south/southwest of the pump. In addition, there is an area north/northwest of the pump that was impacted by crude oil carried by the wind. Once the initial spill response activity is completed, ConocoPhillips plans to work with TetraTech to develop a sampling plan to delineate the extent of the release, and once the extent of the contamination is known, a remediation plan to address the issues. Both the sampling and remediation plans will be submitted to your office for approval prior to implementation.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment. The acceptance of a C-141 report by the NMOCD marked as "Final Report" does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that pose a threat to ground water, surface water, human health or the environment. In addition, NMOCD acceptance of a C-141 report does not relieve the operator of responsibility for compliance with any other federal, state, or local laws and/or regulations.
