

Fire started Heater Treater by fire tubing. Released some fluid 3-4 barrels of which some burned, Recovered 2 barrels, while sucking up stand fluid. Pulled the remaining fluid out of treater (7 barrels) and began maintenance.

Describe Area Affected and Cleanup Action Taken.*

Area affected was right around Heater treater, all fluid stayed within the isolated berm area. Removed fluids, gravel and 2" of soil, and Replaced with clean material. Hauled off approximately 5 yds of soil + gravel to CRD.
