Dear Ms. Staley:

Reference is made to your application dated August 4, 1998, which was received by the New Mexico Oil Conservation Division ("Division") in Santa Fe on August 12, 1998, for an exception to the well location requirements provided within the "*Special Rules and Regulations for the Blanco-Mesaverde Pool*," as promulgated by Division Order No. R-10987, for a non-standard gas well location in an existing standard 320.60-acre stand-up gas spacing and proration unit for the Blanco-Mesaverde Pool comprising Lots 3 and 4, the S/2 NW/4, and the SW/4 (W/2 equivalent) of Section 2, Township 30 North, Range 10 West, NMPM, San Juan County, New Mexico. This unit is currently dedicated to Amoco Production Company's: (i) Atlantic "D" Com "D-LS" Well No. 5 (API No. 30-045-09857), the initial well on this unit, located at a standard surface gas well location 1650 feet from the South and West lines (Unit K) of Section 2; and, (ii) Atlantic "D" Com "D-LS" Well No. 5-A (API No. 30-045-22522), located at a standard infill gas well location 1625 feet from the North line and 1475 feet from the West line (Unit F) of Section 2.

The application has been duly filed under the provisions of Division Rules 104.F and 605.B of the General Rules and Regulations of the New Mexico Oil Conservation Division ("Division").

By the authority granted me under the provisions of Division Rule 104.F(2), the following described well to be drilled at an unorthodox gas well location in Section 2 is hereby approved:

**Atlantic Com "D-LS" Well No. 5-B
2310' FSL & 1030' FWL (Unit L)**

Further, Amoco Production Company is authorized to dedicate Blanco-Mesaverde gas production on the subject unit from the proposed Atlantic Com "D-LS" Well No. 5-B with the two existing Atlantic "D" Com "D-LS" Well Nos. 5 and 5-A. These three wells and the existing unit will be subject to all existing rules, regulations, policies, and procedures applicable to prorated gas pools in Northwest, New Mexico.
