Marbob Energy Corporation requests approval for the Dime State #1 unorthodox location described above. The well is unorthodox because this well was originally drilled as a deep prospect and this is where the geophysicist deemed to be the best location. The well was drilled to the Morrow formation and recently has been recompleted. The formation that was completed is the Bone Spring formation. We are the operator of all of the offsetting proration units in this pool except the NE/4SE/4. There is an existing Joint Operating Agreement in place and remains as long as this well is producing. The operator and working interest owners are uniform in the S/2 proration unit of Sec. 30 T18S R28E except for the NE/4SE/4. Notification will be given to that 100% owner. Enclosed is a copy of form C-102 showing the location and proposed proration unit. Also, enclosed is a map showing the proposed proration unit and the offset proration units.


