Dear Mr. Henry:

The New Mexico Oil Conservation Division (OCD) has received Plains' report and request to close the above-referenced site (dated, February, 2009) for groundwater monitoring. The above-referenced report indicates that Plains has met partial fulfillment of the requirements of 19.15.29 NMAC (Part 29, formally, Rule 116) for this site. Therefore, the OCD hereby conditionally approves the Plains' request for groundwater closure and no further groundwater monitoring is required for this site:

The material used to plug the six groundwater monitoring wells at the Monument 11 Release Site must be a cement grout with 1% to 3% bentonite. Please submit to the OCD a final plugging report within 60 days of receipt of this letter.

Plains must submit an appropriate soils remediation plan to the OCD within 60 days of receipt of this letter.

Please be advised that OCD approval of this report does not relieve the owner/operator of responsibility should operations pose a threat to ground water, surface water, human health or the environment.
