Reference is made to your application dated March 29, 1999, as amended by letter dated March 30, 1999, for an unorthodox "infill" oil well location within an existing standard 40-acre oil spacing and proration unit comprising the SW/4 SW/4 (Unit M) of Section 10, Township 19 South, Range 29 East, NMPM, Turkey Track (Seven Rivers/Queen/Grayburg/San Andres) Pool, Eddy County, New Mexico.

This 40-acre unit is currently dedicated to MYCO Industries, Inc.'s ("MYCO") Continental State Well No. 5 (API No. 30-015-03575) located at a standard oil well location 330 feet from the South and West line of Section 10.

Further, the S/2 SW/4 of Section 10 is a single State lease (New Mexico State Land Office Lease No. B-08096-0024) in which MYCO is the leasehold operator; therefore, there are no effected offsets to the subject 40-acre tract other than MYCO.


The application has been duly filed under the provisions of Rule 104.F of the Rules and Regulations of the New Mexico Oil Conservation Division ("Division").
