By Administrative Order No. NSL-4295, the Division approved an unorthodox well location for the Yates Petroleum Corporation Concho "ACT" State Com Well No. 1 to be drilled as a straight hole from a surface location 1650 feet from the North line and 660 feet from the East line of Section 8, Township 17 South, Range 27 East, NMPM, Eddy County, New Mexico.

Yates drilled the Concho "ACT" State Com Well No. 1 at the proposed unorthodox location but has been unsuccessful in making a well in the Lower Morrow Clastics interval. Yates Petroleum Corporation therefore seeks to amend Order No. NSL-4295 to permit it to directionally drill from the current wellbore to a new unorthodox bottomhole location 1980 feet from the North line and 660 feet from the East line of said Section 8.

Attached hereto are letters from OXY USA, Inc. and Chi Energy, Inc., the only affected offsetting operators, waiving objection to the new unorthodox bottomhole location.

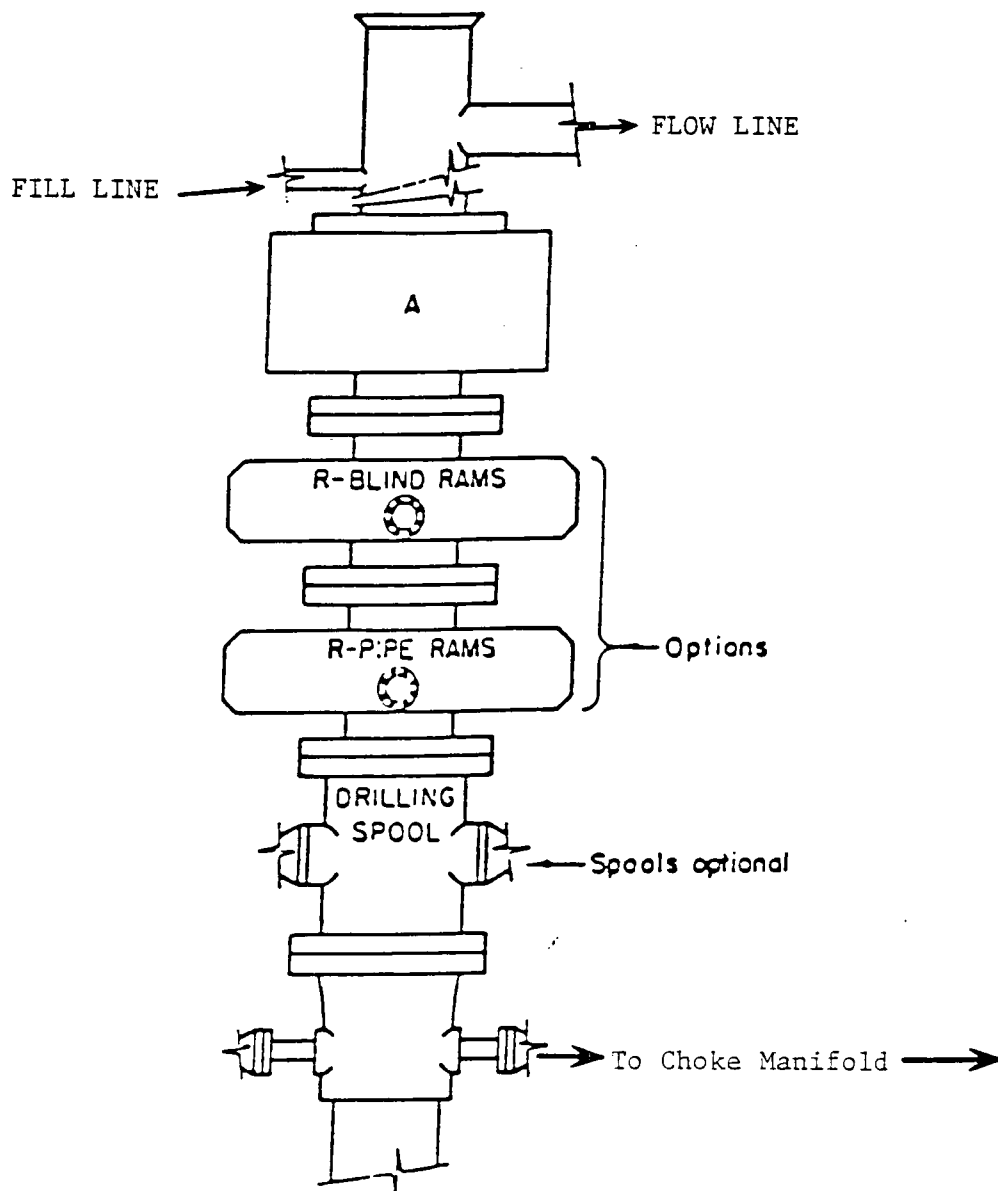

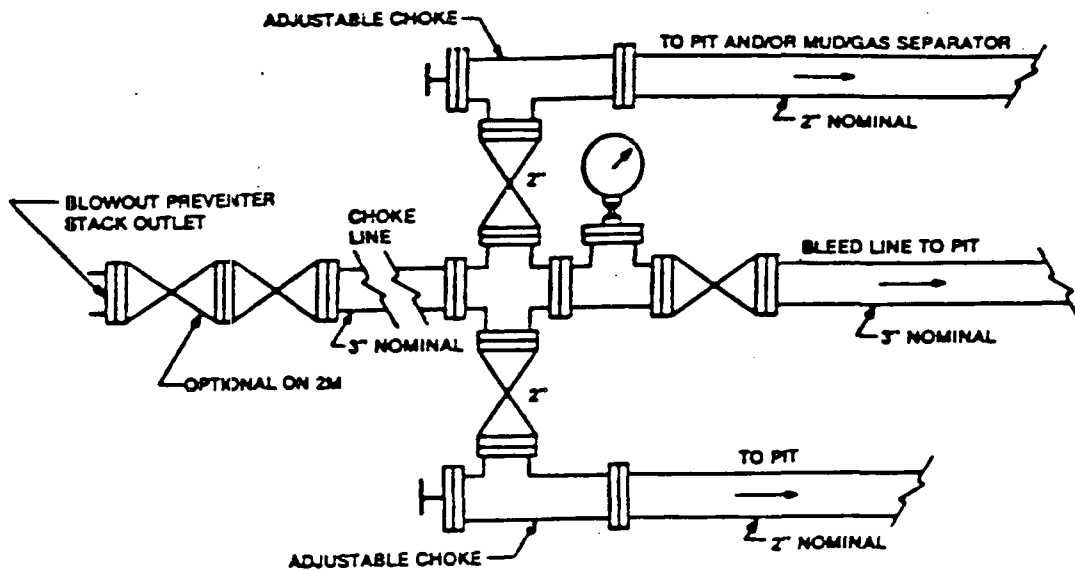

Typical choke manifold assembly for 3M WP system

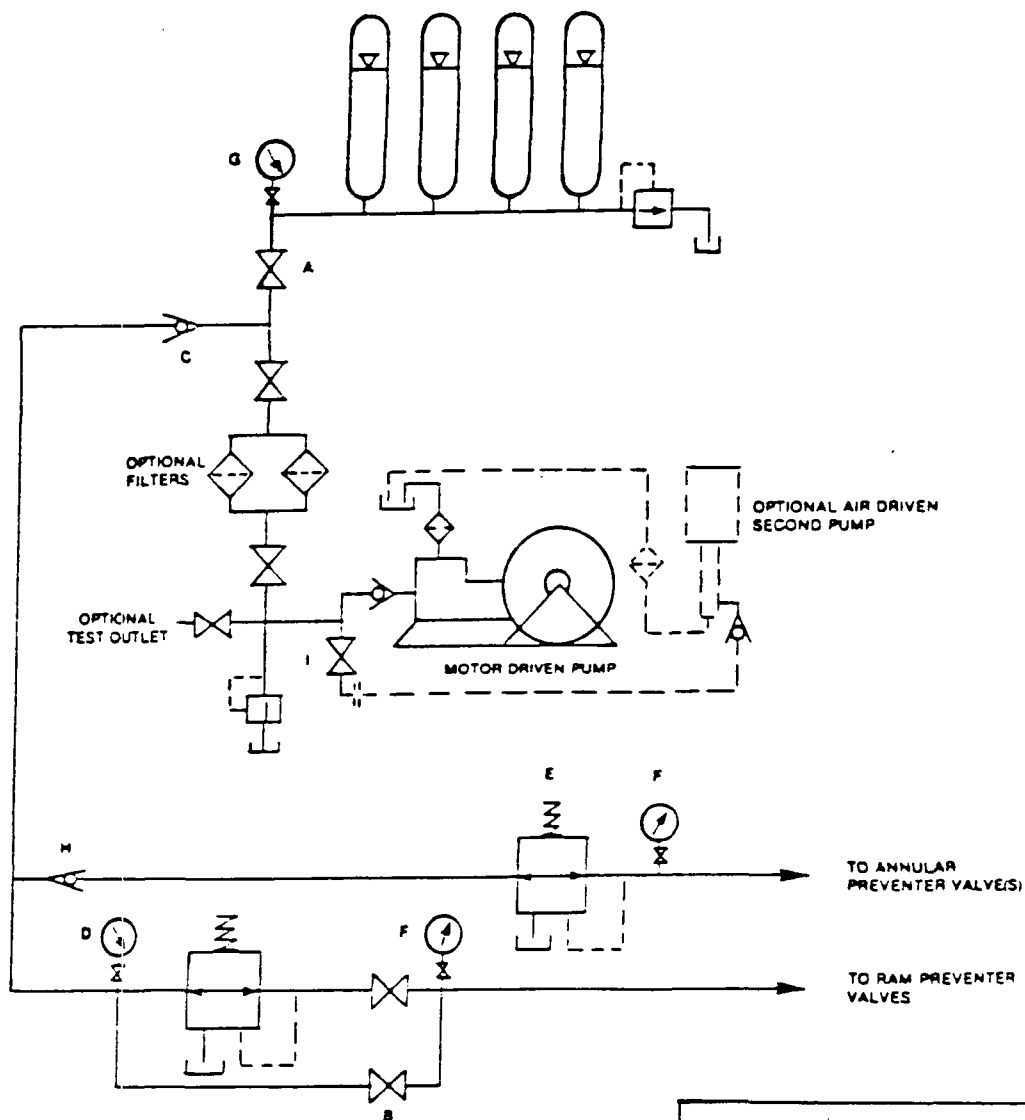
