Texland Petroleum-Hobbs, LLC, 777 Main Street, Suite 3200, Fort Worth, Texas 76102, has filed Form C-108 (Application for Authorization to Inject) with the New Mexico Oil Conservation Division seeking administrative approval to reenter the White #1, located 1886' FSL & 511' FEL, Section 30, Township 16 South, Range 38 East, Lea County, New Mexico, and convert it to a salt water disposal well in the San Andres Formation from 5778' to 5995'. The maximum injection rate will be 500 BWPD at a maximum surface injection pressure of 2000 psi. Injection water will be sourced from area wells producing from the Drinkard formation. The disposal water will be injected into the San Andres Dolomite.
