Dear Mr. Fielder:

Reference is made to the following:

(a) your application (**administrative application reference No. pKAA09-13451585**) submitted to the New Mexico Oil Conservation Division (the Division) in Santa Fe, New Mexico, on behalf of West Largo Corp. (West Largo), on May 14, 2009, and

(b) the Division's records pertinent to this request.

West Largo has requested to drill the above-referenced well at an unorthodox well location described above in the caption of this letter. The SW/4 (equivalent) of irregular Section 30 and Lots 5 through 12 (W/2 equivalent) of irregular Section 31 will be dedicated to this well in order to form a standard 320-acre gas spacing unit in the Basin Fruitland Gas Pool (71629). Spacing in this pool is governed by the Special Rules and Regulations for the Basin-Fruitland Coal Gas Pool, as amended by Order No. R-8768-F, effective July 17, 2003, which provide generally for 320-acre units with wells to be located at least 660 feet from any unit boundary. This location is less than 660 feet from the western unit boundary.

Your application on behalf of West Largo has been duly filed under the provisions of Division Rules 15.13 and 4.12.A(2).

It is our understanding that you are seeking this location for topographic reasons.


