Mr. Jones,

I will make this as short and concise as possible. We were granted a permit (Administrative Order SWD-1124) to inject as water disposal for the above mentioned well (Brooks Federal #3) on May 14, 2008. After doing much work we were unable at the time to locate plastic lined tubing to fit this well (2 1/16") and closed the operation and made another request to use Brooks Federal # 7 for this purpose. Permit was approved and we started work on that well which included purchase of the necessary 2 3/8" plastic lined tubing. In our work on this well we found that the casing increased in size a partial way down hole therefore we were unable to get a packer to the required depth. After much searching we were able to locate a company that would plastic line our 2 1/6" tubing for #3. We thought we could complete all the work by 5-14-09 but were unable to do so. We have set the tubing and packer and run a modern porosity log and will have the step rate test completed this week. All this information will be supplied to the Hobbs field office as soon as completed. They have advised we do need to get an extension before actual injection begins.

Would you please advise me at your earliest convenience what other actions I may need to take to complete this extension request.
