By this letter of application Amerada Petroleum Corporation wishes to  
state the following:

- (a) That Amerada Petroleum Corporation requested by  
letter of application dated April 1, 1955, permis-  
sion to dually complete the State "T" No. 5 located  
1980 ft. FNL and 1980 ft. FEL of Section 20, T 19-S,  
Range 37-E, Lea County, New Mexico.
- (b) That the applicant proposes to assign this well a  
non-standard gas proration unit consisting of 320  
acres which is the N/2 of Section 20, T 19-S, Range  
37-E, Lea County, New Mexico.
- (c) That the proposed non-standard gas proration unit  
lies wholly within a single governmental section.
- (d) That the proposed non-standard gas proration unit  
may reasonably be presumed to be productive of gas
- (e) That the proposed non-standard gas proration unit  
does not exceed 5280 feet in length or width and  
consists of contiguous quarter-quarter sections.
- (f) That by copy of this letter of application by regis-  
tered mail all offset operators are notified.

Therefore, Amerada Petroleum Corporation requests that the Oil Conser-  
vation Commission grant approval of this non-standard gas proration  
unit as proposed in this application.

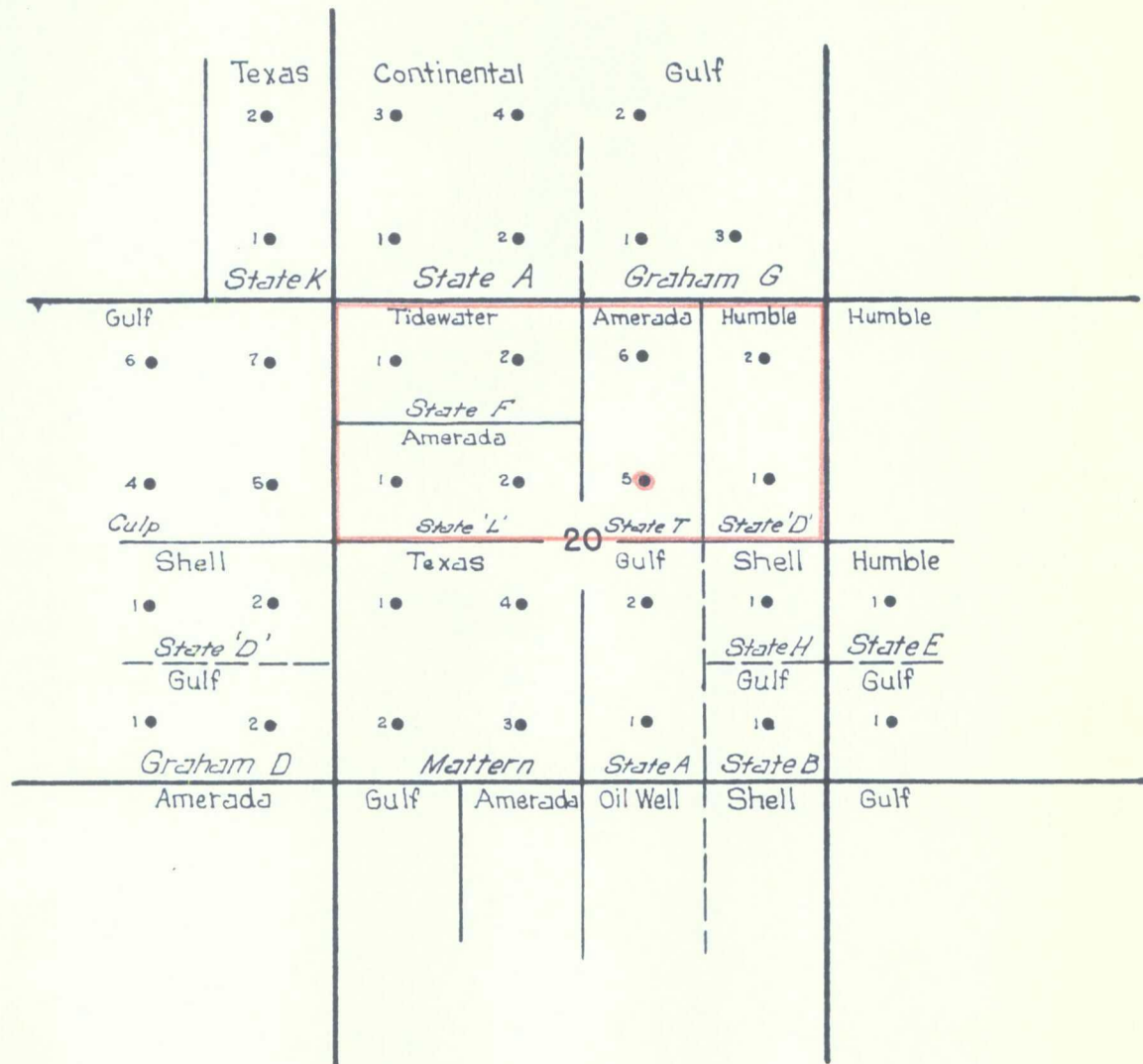
