5(a) of Order No. R-520 for Amerada  
Federal "D" No. 5, Eumont Gas Pool

Gentlemen:

By this letter of application Amerada Petroleum Corporation  
wishes to state the following:

- (a) That Amerada Petroleum Corporation Federal "D" No. 5 located 660' FSL and 660' FWL of Section 26, Township 20-S, Range 36-E, was dually completed under authority of O.C.C. Order No. D.C. 187 dated March 13, 1955.
- (b) That the applicant proposed to assign this well a non-standard gas proration unit consisting of 160 acres which is the SW/4 of Section 26, Township 20-S, Range 36-E.
- (c) That the proposed non-standard gas proration unit lies wholly within a single governmental section.
- (d) That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- (e) That the proposed non-standard gas proration unit does not exceed 5280 feet in length or width.
- (f) That by copy of this letter of application all operators owning interests (1) in the subject section and (2) within 1500 feet of the subject well of the proposed gas unit are notified by registered mail of this proposed non-standard gas proration unit.

Therefore, Amerada Petroleum Corporation requests that through provisions of Rule 5(b) of Order No. R-520, the Secretary of the Oil Conservation Commission approve the subject non-standard gas proration unit as proposed in this application.

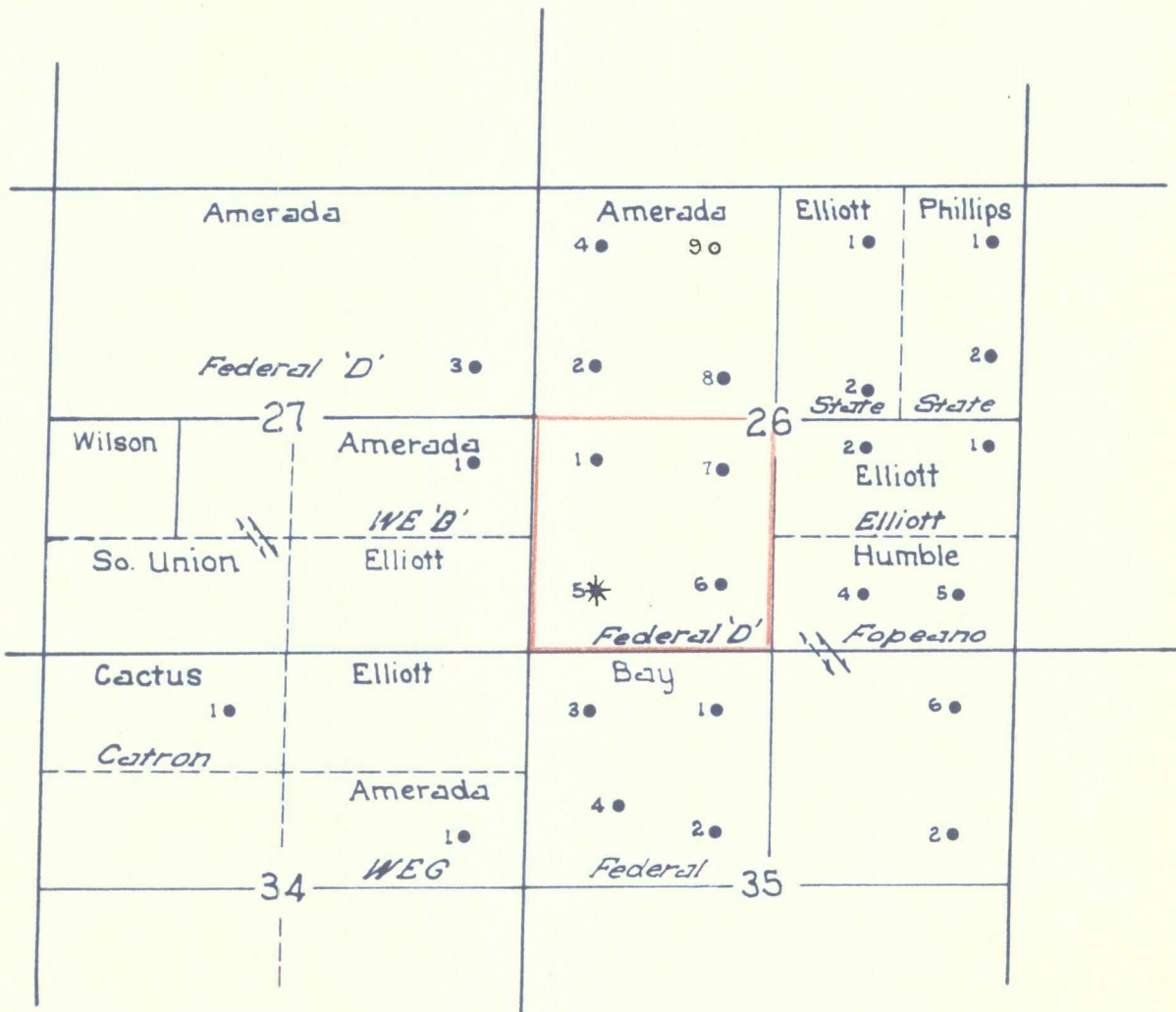
