This is a request for administrative approval for a non-standard gas well location in the Blanco Mesaverde and Basin Dakota pool.

The proposed San Juan 30-5 Unit 85N was staked as a commingled MV/DK well. The placement of the well is non-standard for the Dakota pool per Order R-10987B (2) and for the MV pool per Order R-10987-A(1) because the entire section is not part of the DK or MV Participating Areas (PA). The well is staked in the NW/4 of Section 36 which is not in the PA and is staked closer than 660' from the E/2 & S/2 section lines of which is in the PA, therefore both the MV & DK are NSL for this well. The well is staked non-standard due to the constrictions of major topography on all sides. The current location was very difficult to obtain due to topography.

Production from the Basin Dakota and Blanco Mesaverde are included in the 320.00 acres gas spacing unit, W/2 Section 36, T30N, R5W.

To comply with the New Mexico Oil Conservation Division rules, we are submitting the following to help with your decision process:

1. Approved APD cover page and C102 plat showing location of the well
2. 9 Section Plan showing wells in the area
