By this letter of application, Albert Gackle, Operator, states as follows:

- 1. The applicant seeks a non-standard gas proration unit of 320 acres comprising the south half of Section 27, Township 23 South, Range 36 East, and attributed to the above described well, in accordance with the provisions of Order R-520, Rule 5, Paragraph (c).
- 2. The W. H. Combest No. 1 is located 1650 feet from the south line and 990 feet from the east line of the Section as herein described. The dry gas well was completed April 9, 1949, and the Operator is requesting the 330 foot tolerance rule as defined in Order R-520.
- 3. The entire unit of 320 acres can be reasonably assumed to be productive of dry gas.
- 4. The operating and royalty interests are the same over the entire south half of Section 27 as herein described.
- 5. The dry gas well was recently "sand-oil fraced" to increase its productive capacity, and thereby assure the Operator of a top allowable proration unit of 320 acres.

This office is in receipt of your application for an approval of an exception to Rule 5 (a) of the Special Rules and Regulations for the Jalmat Gas Pool as set out in Order R-520 to permit the formation of a 320 acre non-standard gas proration unit in the Jalmat Gas Pool and to be assigned to your W. Gentlemen:

Reference is made to your letter of August 30, 1955, in which you requested reconsideration of your application for administrative approval of a 320-acre non-standard gas proration unit.

This Commission is not able to grant administratively under Rule 5 (b) of Order R-520, your request for a 320 acre non-standard gas proration unit. Our records indicate that your well is located 990 feet from the North and East lines of your lease. Under Rule 5 (a) of same order we could grant administratively your request for 320 acres if your well had been located not closer than 330 feet and 1650 feet from the nearest boundary lines of your lease. Your well does not meet the 1650 feet specificaion as it is only 990 feet from both boundary lines. The maximum acreage that we can grant administratively is 160 acres for your wells location.

Your application will be placed on the docket of the October 13, 1955 regular hearing unless we hear from you prior to September 20, 1955.
