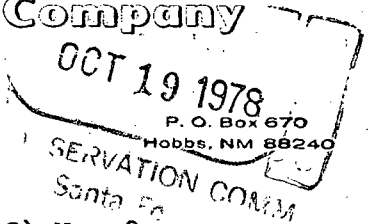

Gulf Oil Corporation requests your administrative approval for an amendment to Order NSP-221A, for a 236.45 acre nonstandard proration unit in the Eumont Gas Zone, consisting of Lots 1, 2, 3, 6, 7 and 8 of Section 6-21S-36E, Lea County, New Mexico to be dedicated simultaneously to our H. T. Orcutt (NCT-C) Com "A" No. 8 (located 660'FNL and 1980'FEL of Section 6) and to our H. T. Orcutt (NCT-C) No. 3 (located 1980'FN and EL of Section 6).

H. T. Orcutt (NCT-C) Com "A" No. 8 was previously dedicated to the aforementioned 236.45 acre nonstandard unit by administrative approval; however, Well No. 8 is incapable of producing top allowable for the 236.45 acre unit.

The H. T. Orcutt (NCT-C) No. 3 is temporarily abandoned in the Eunice-Monument oil pool. Gulf plans to abandon the Eunice-Monument oil pool in this well and recomplete to the Eumont Gas pool. Upon approval of this application we will redesignate the H. T. Orcutt (NCT-C) No. 3 to H. T. Orcutt (NCT-C) Com "A" No. 3 for record keeping purposes and for the allocation of production from the 236.45 acre unit.

In support of this application the following facts are submitted:

- (1) Order NSP-221A authorized the simultaneous dedication of the 236.45 acre nonstandard unit to the No. 8 well.
- (2) There are no other wells producing from the Eumont Gas zone in this nonstandard proration unit.

- (3) The attached plat shows the 236.45 acre unit and wells outlined.
- (4) All offset operators have been furnished a copy of this application by certified mail.

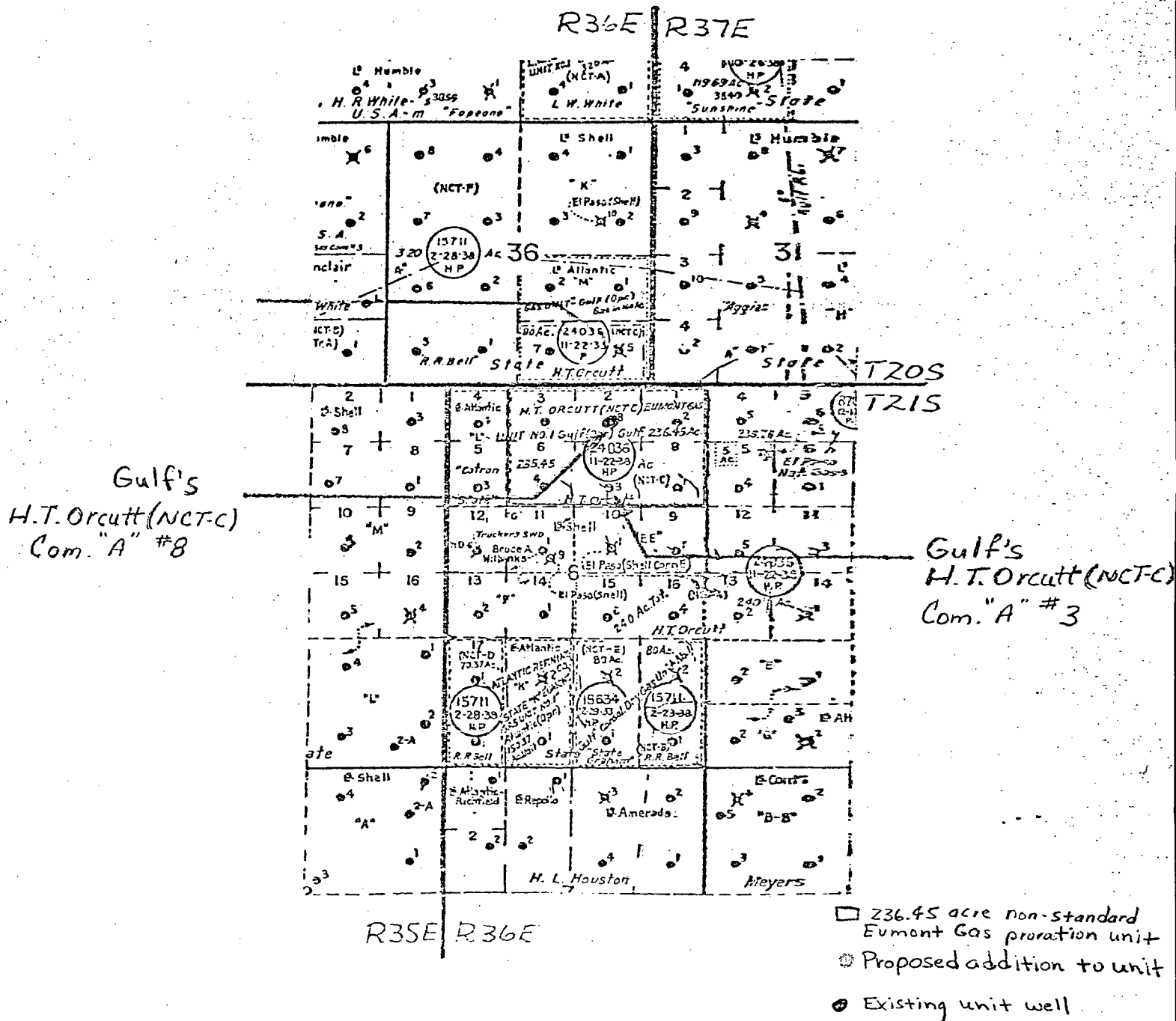
