The State "E" No. 5 is located 1504 from the west line, 1020 from the south line of Section 30-19S-37E, and is to be completed as a Eumont Gas well. An exception to Rule 2, Order R-520 is requested since this well is less than 330' from quarter/quarter section lines. It was necessary to move this location from 1650' from west line, 990' from south line due to the proximity of a Permian Basin gas pipeline. An exception to Rule 5(a) Order R-520 is requested in order to assign the State "E" No. 5 a 160 acre non-standard gas proration unit. This non-standard gas proration unit consists of contiguous quarter/quarter sections within a single governmental section, and the entire area may

reasonably be presumed to be productive of gas.

The attached plat indicates the acreage to be assigned to this well, and the offset ownership.


