The revised remediation plan (dated July 20, 2009) is approved with the following conditions and stipulations:

- As discussed, the portion of the remediation plan that states "Any soil that has very low TPH levels will be remediated onsite to below the RAL's.) refers to blending the impacted material with clean materials to achieve the RAL.
- Notify OCD District 2 Office 48 hours prior to commencement of remedial activities.
- Notify OCD District 2 Office 48 hours prior to obtaining samples where analyses of samples obtained are to be submitted to OCD.
- Target project completion date will be August 20, 2009.

Please be advised that this approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, this approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
