Gentlemen:

Gulf Oil Corporation hereby makes application for approval of a non-standard gas proration unit comprising the W/2 of Section 28, T-19-S, R-37-E, Lea County, New Mexico, and in support thereof states the following facts:

- (1) Gulf Oil Corporation is owner and operator of an oil and gas lease known as its F. W. Kutter "B" Lease, located in the S/2 and NW/4 NW/4 of Section 28, T-19-S, R-37-E, Lea County, New Mexico. Sinclair Oil & Gas Company is owner and operator of an oil and gas lease known as its Bordages Lease, located in the SW/4 SW/4 and NE/4 NW/4 of Section 28, T-19-S, R-37-E, Lea County, New Mexico. Amerada Petroleum Corporation is the owner and operator of an oil and gas lease known as its State "T" Lease located in the N/2 SW/4 of Section 28, T-19-S, R-37-E, Lea County, New Mexico. Great Western Drilling Company is the owner and operator of an oil and gas lease known as its F. C. Schmidt Lease, located in the SE/4 SW/4 of Section 28, T-19-S, R-37-E, Lea County, New Mexico. The Gulf, Amerada, Sinclair and Great Western leases comprise the 320 acres above described.
- (2) Gulf Oil Corporation proposes that the above described acreage be established as a non-standard 320-acre gas proration unit in exception to Rule 5 (a) of Order R-520.
- (3) Gulf Oil Corporation is the owner and operator of the F. W. Kutter "B" Well No. 4, located 1,980 feet from the

North line and 1,650 feet from the West line of Section 28, T-19-S, R-37-E, Lea County, New Mexico, which was completed July 22, 1956, as a gas-oil dual well. This well is in the Eumont Gas Pool and Monument oil Pool.

- (4) Gulf Oil Corporation, Amerada Petroleum Corporation, Sinclair Oil & Gas Company and Great Western Drilling Company are in the process of preparing agreements for the communitization of their respective leases in the above described half section and for the operation of said half section after communitization as a non-standard 320-acre gas proration unit. Gulf's above described F. W. Kutter "B" No. 4 is to be the unit well for the proposed 320-acre unit.
- (5) In order to obtain a pipe line connection and gas allowable for Gulf's F. W. Kutter "B" No. 4, Forms C-104, C-110 and C-128 have been duly filed. Pending the furnishing to the Land Commissioner satisfactory evidence of communization of Gulf's, Amerada's, Sinclair's and Great Western's acreage in the proposed 320-acre unit and approval of the unit by the Land Commissioner, Gulf desires to produce an 120-acre gas allowable all of which would be attributable to Gulf's 120-acre F. W. Kutter "B" Lease described as the S/2 and NW/4 NW/4 of Section 28, T-19-S, R-37-E, Lea County, New Mexico.
- (6) The proposed non-standard gas proration unit will meet the requirements of Rule 5 (b) of the Oil Conservation Commission Order No. R-520 as follows:
 - (a) Contiguous quarter-quarter sections will comprise the unit.
 - (b) The proposed unit lies wholly within a single governmental section.
 - (c) All acreage within the proposed unit may reasonably be presumed productive of gas.
 - (d) The length or width of the proposed unit does not exceed 5,280 feet.
 - (e) By copy of this letter of application, all operators accruing interest in the section in which the proposed unit is located and all operators within 1,500 feet of the proposed unit well are notified by registered mail of the intent of Gulf Oil Corporation,

Amerada Petroleum Corporation, Sinclair
Oil & Gas Company and Great Western
Drilling Company to form the proposed non-
standard gas proration unit. (See attached
affidavit.)

- (7) The approval of this application for a 320-acre non-standard gas proration unit with the assignment of only a 120-acre allowable to Gulf's F. W. Kutter "B" No. 1 until such time as communitization is completed will, in the opinion of the applicant, prevent waste, protect correlative rights and serve the best interest of conservation.

In view of the existence of the facts herein stated and compliance with the provisions of Rule 5 (b) of the Oil Conservation Commission's Order No. R-520, Gulf Oil Corporation requests that the Secretary of the Commission approve the above described gas proration unit and issue an administrative order which will authorize the applicant to produce a 120-acre allowable in accordance with applicable pool rules until the date the communitization of the leases in the proposed 320-acre unit has been completed and the Commission authorizes the production of a 320-acre unit allowable.

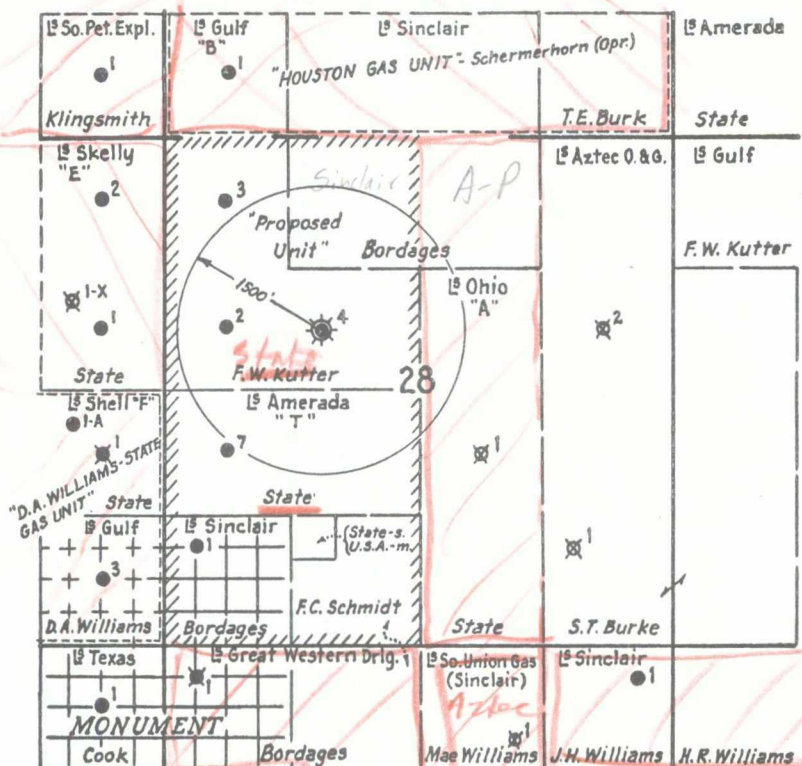
