Gentlemen:

Humble's New Mexico State "M" Well No. 1 was completed May 1, 1940, in 6-1/4-inch open hole from 3609 feet to 3715 feet with 7-inch casing set at 3609 feet and by natural flow produced at the rate of 1308 barrels of oil per day with a gas-oil ratio of 810 when flowed on a 1-inch choke. Completion was from the Queen and Grayburg formations in the Arrowhead Pool. Production declined to such a point that it was recently necessary to work the well over by setting a retainer at 3595 feet and squeezing the producing section 3609 feet to 3715 feet. Well was then perforated in the Queen from 3530 feet to 3550 feet and sand-oil fractured. On a 24 hour test through 1/2-inch choke taken on August 5, 1956, the well produced 15 barrels distillate, 1713 MCF gas for a ratio of 108080. On the basis of the results obtained from the workover, we respectively request that the well be classified as a Eumont Field Gas well and assigned a 160 acre non-standard gas proration unit.

- 1. Name and location New Mexico State "M" Well No. 1, 1980 feet from the South and East lines of Section 18, T-22-S, R-37-E, Lea County, New Mexico.
- The acreage to be dedicated is 160 acres described as the SE/42. Section 18, T-22-S, R-37-E.
- The non-standard gas proration unit consists of contiguous 3. quarter-quarter sections.

- 4. The non-standard gas protation unit lies wholly within a single governmental section
- 5. The entire non-standard gas proration unit may reasonably be presumed to be productive of gas.
- WW WAR 6. All operators owning interests within 1500 feet of the well have been notified by registered mail.
