
Reference is made to your application dated May 20, 1992 to revert back to the previously existing 160-acre non-standard gas spacing and proration unit in the Eumont Gas Pool comprising the N/2 N/2 of Section 29, Township 20 South, Range 37 East, NMPM, Lea County, New Mexico, which was originally authorized by Division Administrative Order NSP-315, dated September 10, 1956 and reconfirmed by Division Order No. R-6276, dated February 26, 1980. Further, Division Order No. R-6276-A, dated January 9, 1984, authorized the simultaneous dedication of said 160-acre unit to the A.B. Reeves Well Nos. 6 and 7 located in Units A and C, respectively.

By an amendment to Division Administrative Order NSP-315, dated August 8, 1990, a 120-acre non-standard gas proration unit comprising the NW/4 NE/4 and N/2 NW/4 of said Section 9 was established for the No. 7 well whereby the NE/4 NE/4 of said Section 29 was removed from the 160-acre unit since the No. 6 well had subsequently been reclassified an "oil well" and had rededicated thereon the corresponding 40-acre tract comprising the NE/4 NE/4 of said Section 29. Also, said Amended NSP-315 order placed in abeyance the original Order NSP-315, Order No. R-6276 and Order No. R-6276-A.

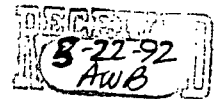
