During our last phone discussion regarding your review of the remediation strategy report for the DCP Plant to Lea Station #2 site (1R-2136) you had requested that Plains obtain an additional bottomhole sample from the excavated area. A 5-point composite soil sample (*Comp. Floor @ 15'*) was collected from the bottomhole of the excavation on 06/24/2009 and submitted for laboratory analyses of TPH and BTEX.
