It is requested that surface commingling of Little Lucky Lake; Wolfcamp and Wildcat; Abo pools be approved for the following lease: Peery Federal (NMNM-119274) Sec. 29, T15S, R30E ✓

The tank battery is located in the SW/4 SE/4, Sec. 29 T15S R30E. Proper allocation for production will be measured using periodic well tests. Mack Energy has made notification to all parties owning an interest in this lease, including the oil purchaser, of the intent to commingle. Interests in all pools on this lease are common.

Mack Energy is currently producing the Peery Federal #5,7 in the Wolfcamp and intend to complete the #6 in the Abo formation. At this time we are requesting approval to add the Abo to this production.
