Gentlemen:

Administrative Order NSP-596 was approved May 14, 1962 for a 160 acre non-standard gas proration unit to comprise the SW/4 of Section 28, Township 24 South, Range 37 East, Lea County, with said acreage dedicated to Woolworth No. 3 located 990 feet from the South line and 990 feet from the West line of said Section 28.

On May 21, 1962 Woolworth No. 4, located 1650 feet from the South line and 990 feet from the West line of Section 28, was disconnected by El Paso Natural Gas Company and shut in.

During the ensuing three years the flowing pressure on Well No. 3 has declined and is often unable to feed into El Paso's gathering lines; whereas Well No. 4 has shown a steady build up of surface pressure.

In order that the gas proration unit established by NSP-596 may be effectively produced with greater ultimate recovery it is respectfully requested that Administrative Approval be granted for the common dedication of allowable to the Weir Drilling Company Woolworth No. 3 and No. 4. In this manner each well may be produced as flowing pressures will permit, with each well to share in the unit allowable in the proportion that it is capable of producing.

Attached is a plat showing the location of the subject wells and offset operators. Each of these offset operators have been furnished a copy of this application at the address shown below.

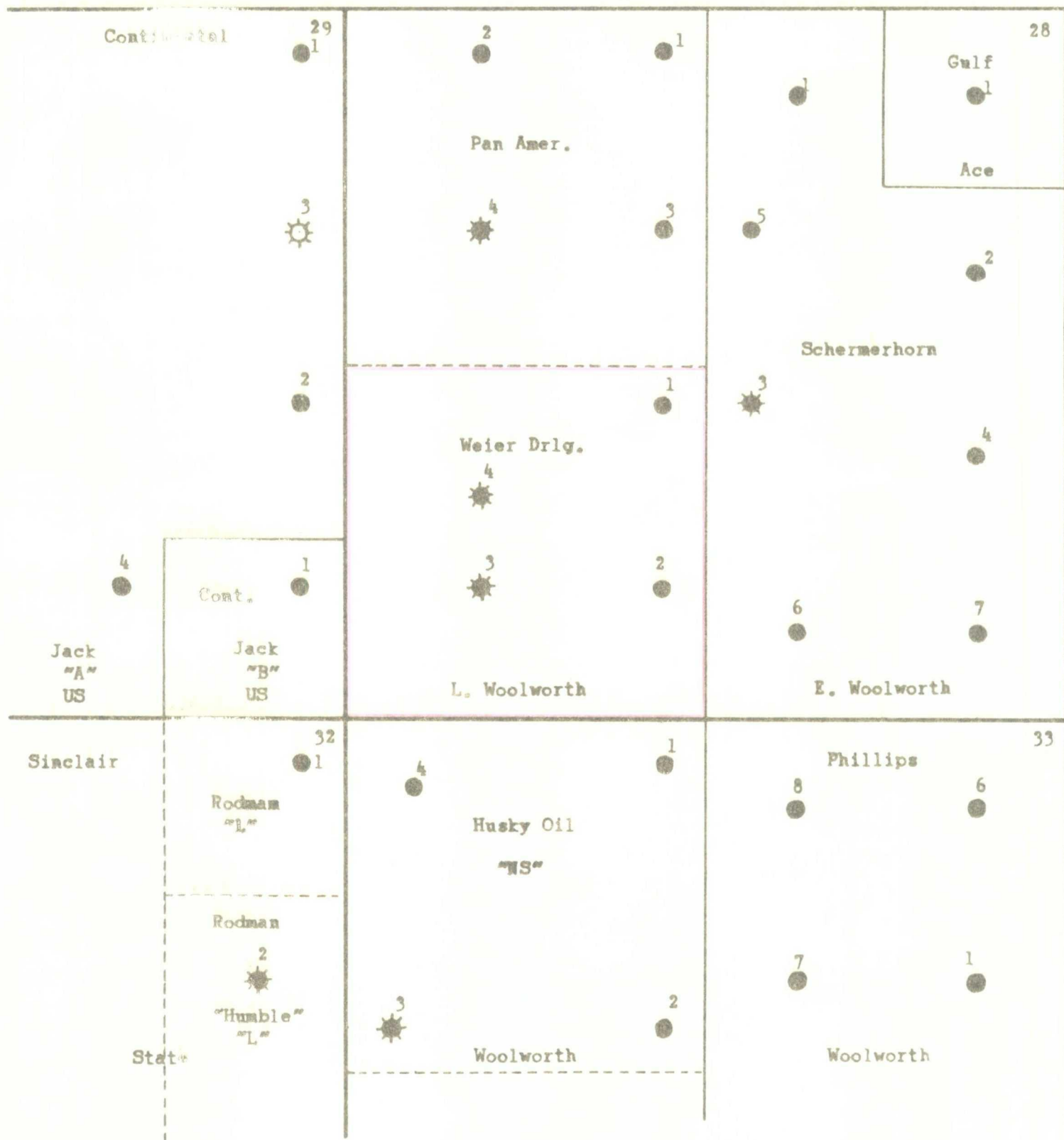
