I have just filed a Communitization Agreement on all of Section 19 for the Standard Federal #1 Well. This is a gas well and producing from the Cisco Canyon Formation in the Upper Pennsylvanian Gas Pool. This is a short section as it contains only 576.12 acres. The U.S.G.S. has informed me that before we can get the Agreement approved we will need a N.S.P. Order. This is due to the shortage of acreage in this section. It is my understanding that this can be done administratively and would appreciate it if you would consider this brief letter as a request for such N.S.P. Order.


